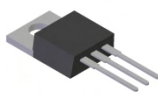

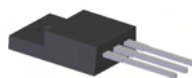

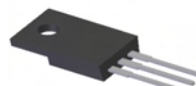

Top View



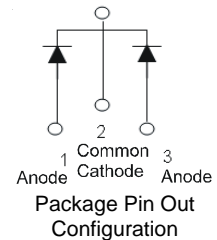

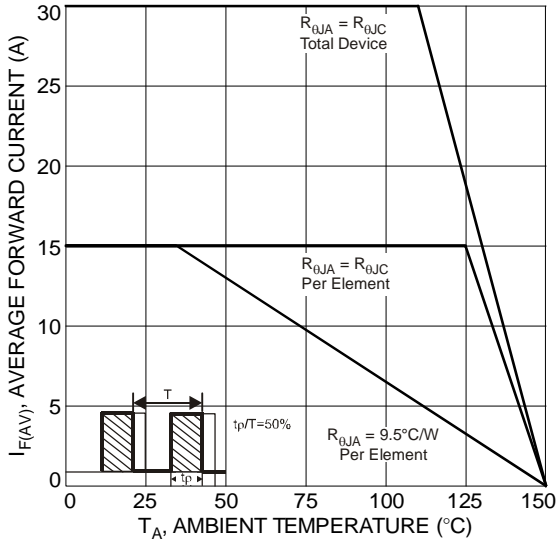


Fig. 3 Forward Current Derating Curve, Per Element
