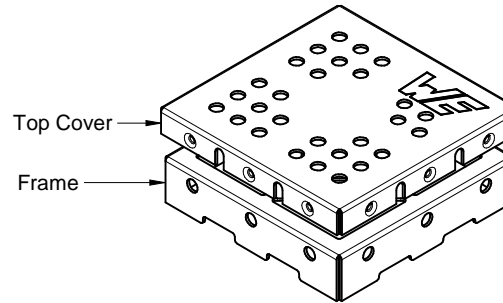


sectional drawing A-A

6. Product Life Cycle


