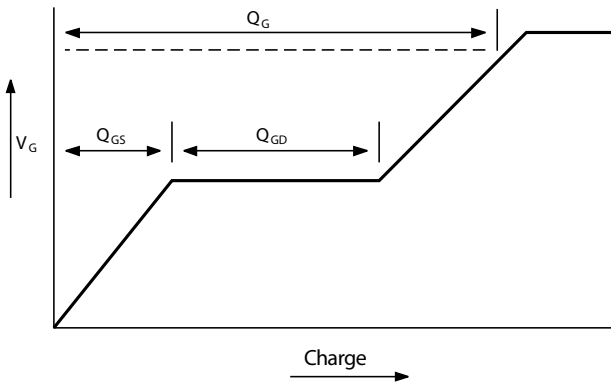

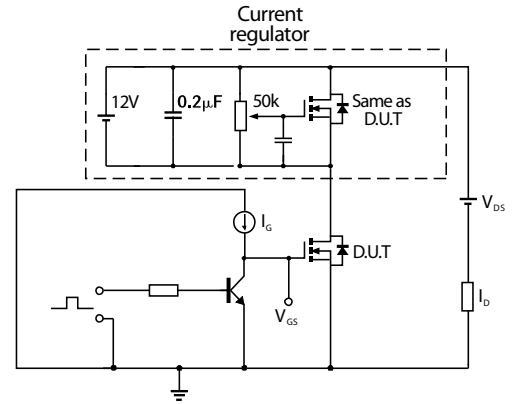

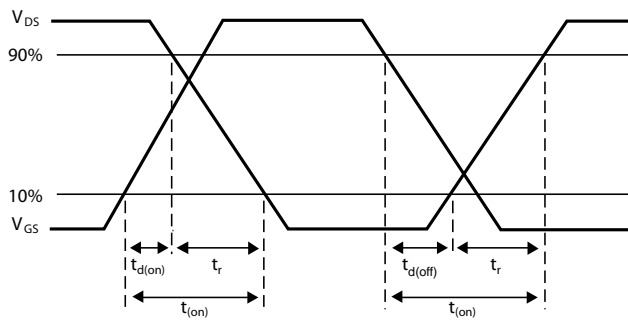

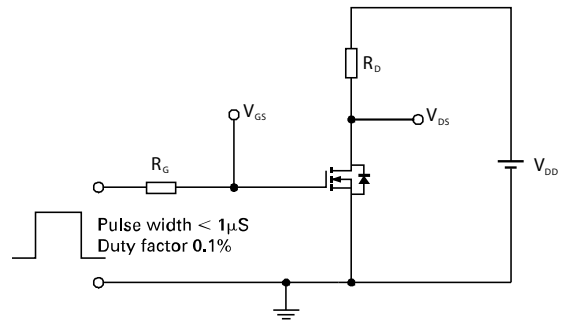
**Basic gate charge waveform**



**Gate charge test circuit**

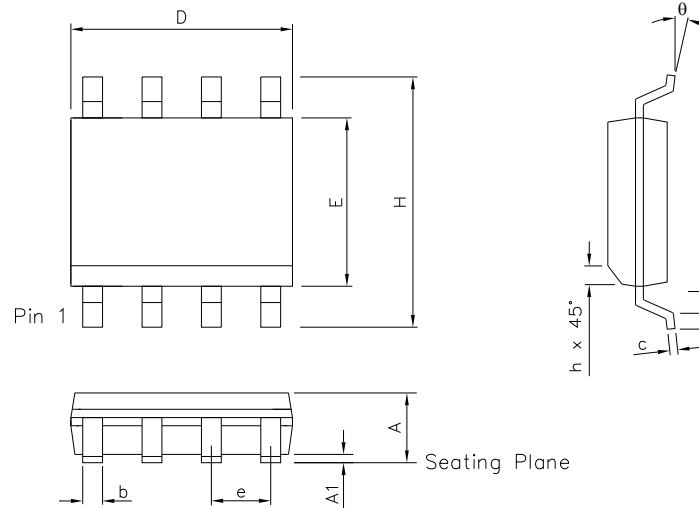


**Switching time waveforms**



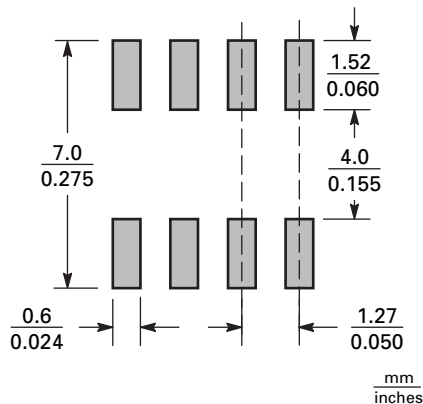
