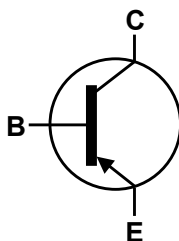

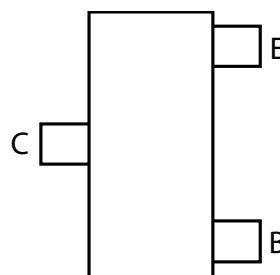

Top View



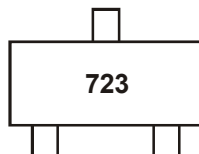
Device Symbol

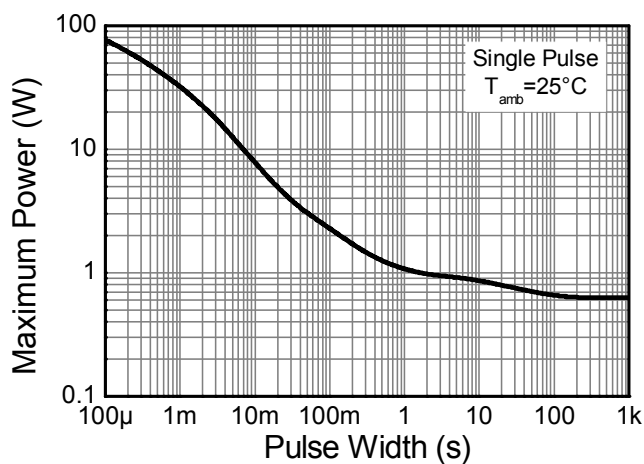

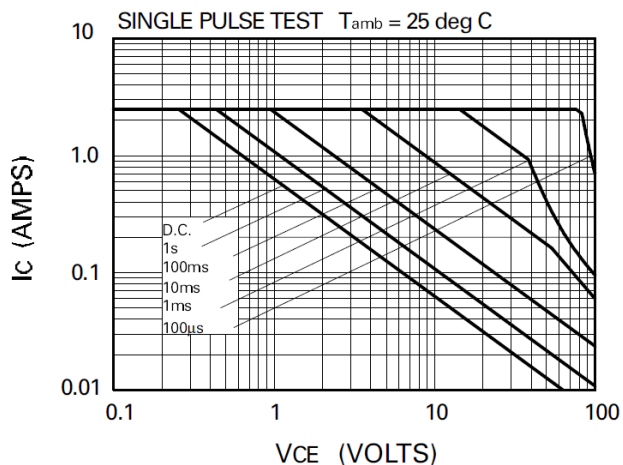
Transient Thermal Impedance

Pulse Power Dissipation



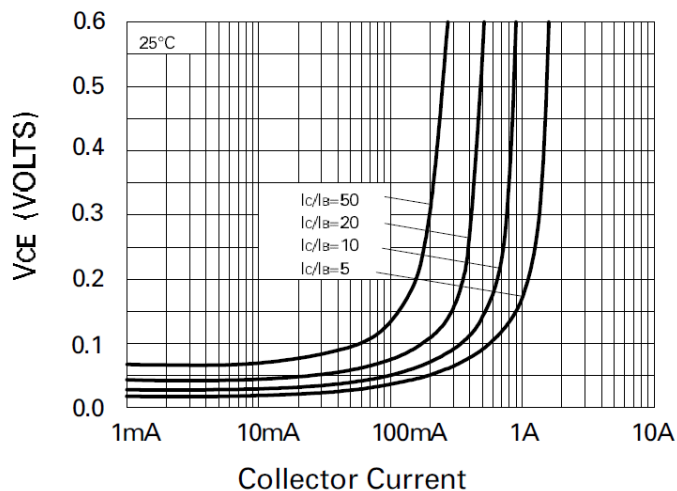

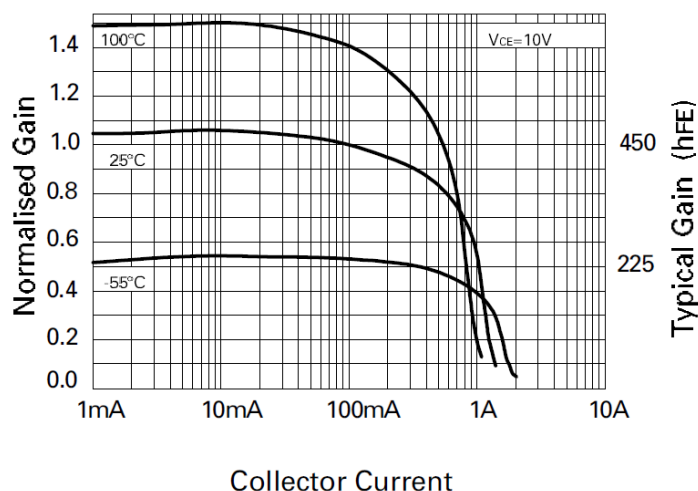

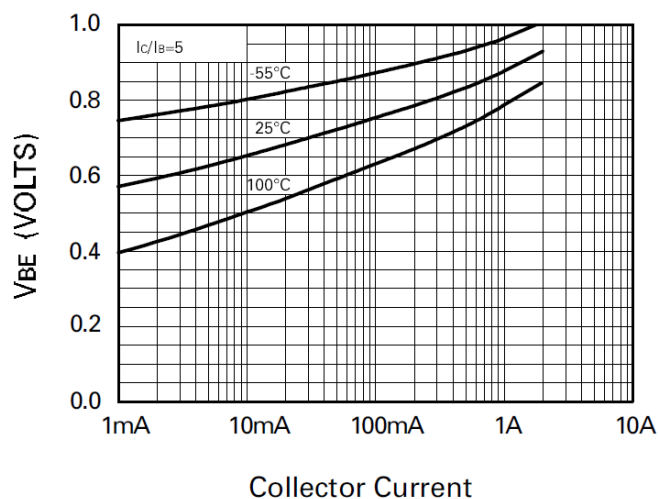
$V_{CE(SAT)}$ vs I_C



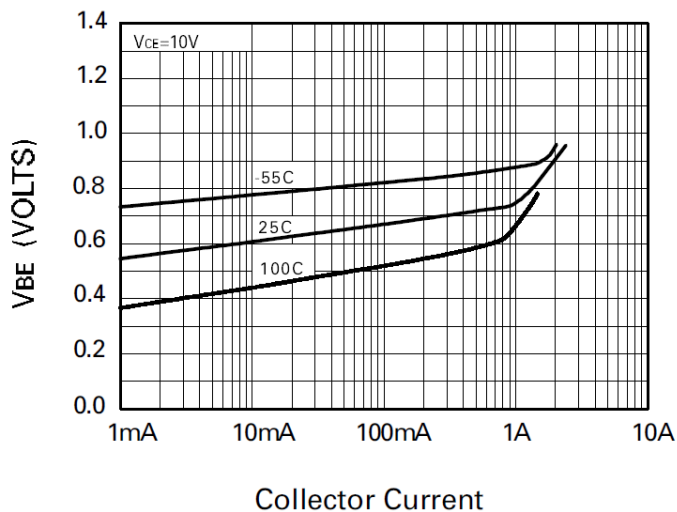
$V_{CE(SAT)}$ vs I_C



h_{FE} vs I_C



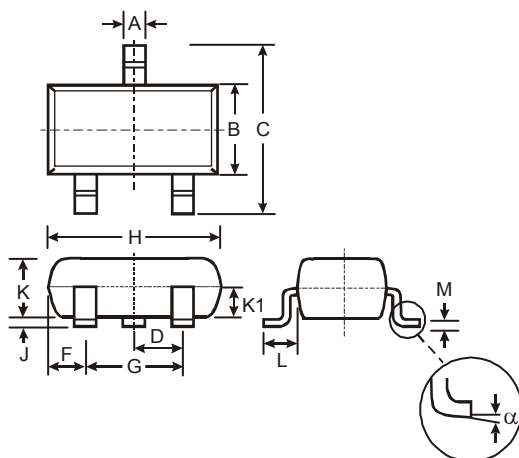
$V_{BE(SAT)}$ vs I_C

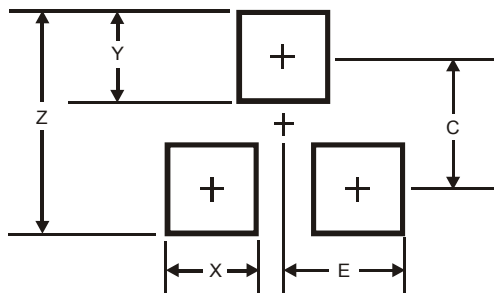
