


Figure 1. Static Characteristic




Figure 3. Base-Emitter Saturation Voltage Collector-Emitter Saturation Voltage




Figure 5. Current Gain Bandwidth Product




Figure 2. DC current Gain





Figure 4. Collector Output Capacitance




Figure 7. 3LEAD, TO92, JEDEC TO-92 COMPLIANT STRAIGHT LEAD CONFIGURATION (OLD TO92AM3)
