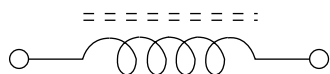

Electrical Schematic

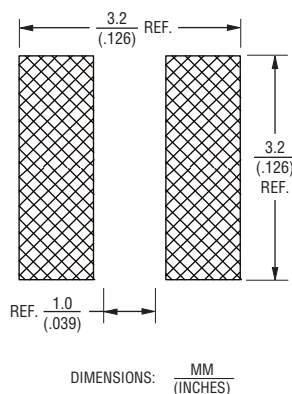

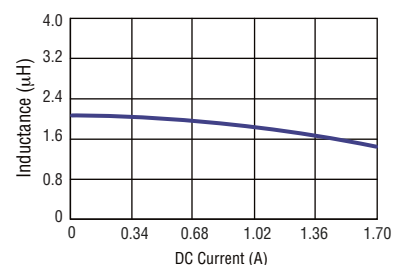
