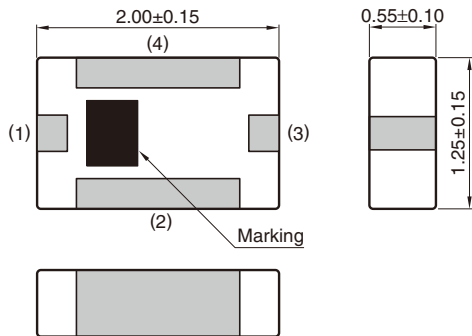

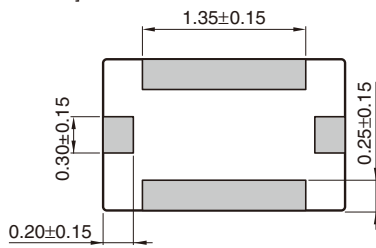

[Bottom view]

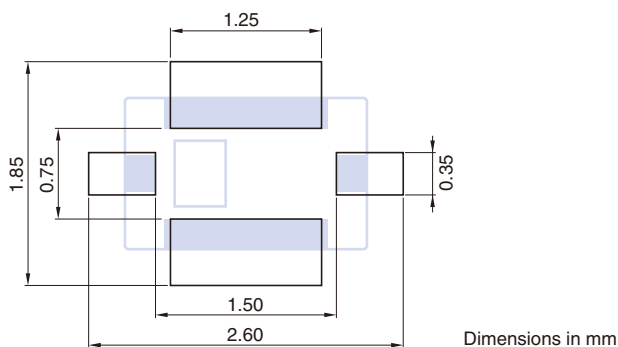

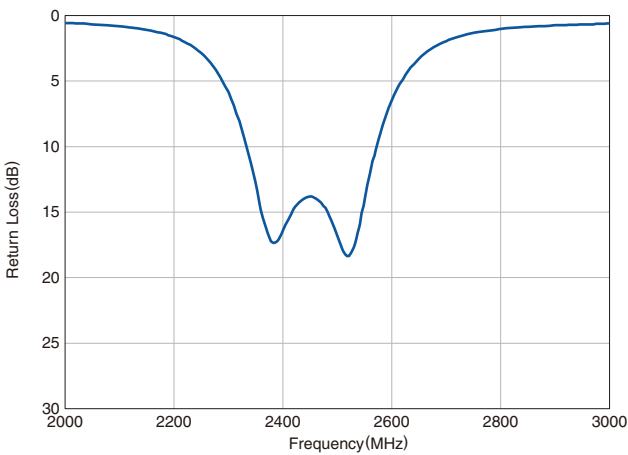
### INSERTION LOSS
