

Fig.1 Input voltage vs. output current (ON characteristics)




Fig.2 Output current vs. input voltage (OFF characteristics)




Fig.3 Output current vs. output voltage






Fig.4 DC current gain vs. output current



OUTPUT CURRENT : Io [A]

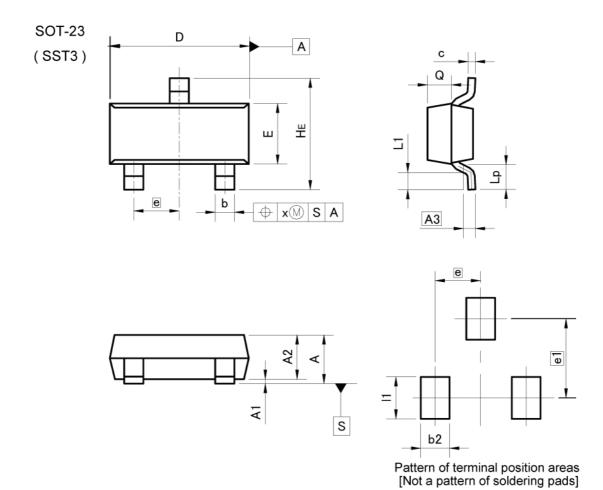
●Electrical characteristic curves (T_a =25°C)
