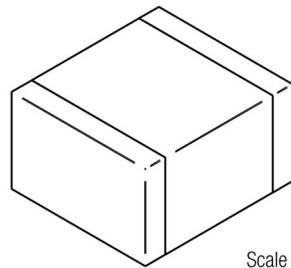

F Derating Curve:

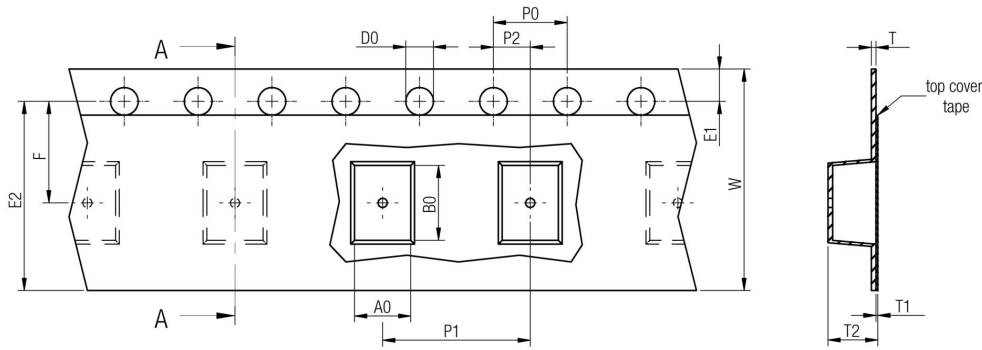
