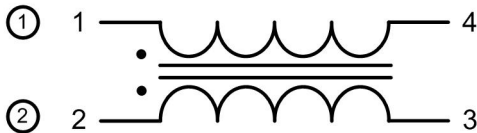

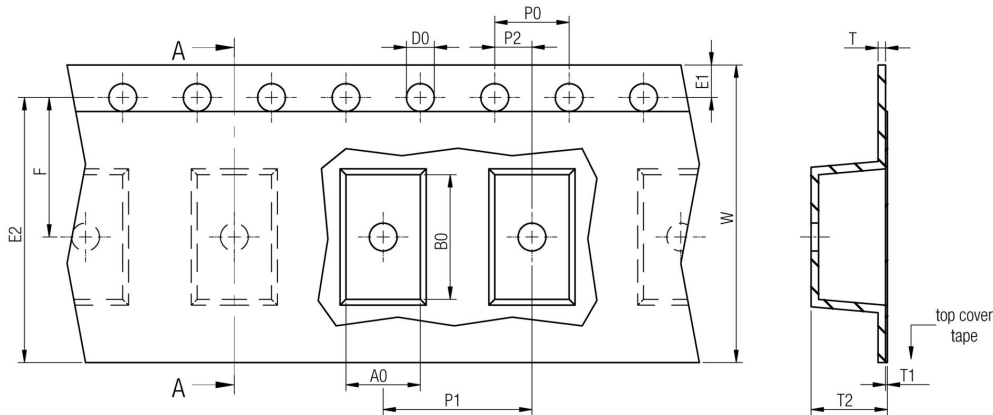


Differential Mode

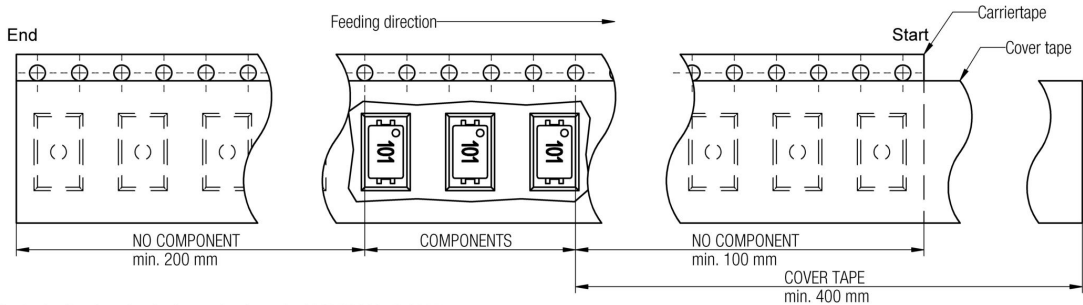
