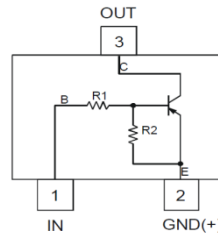

Top View

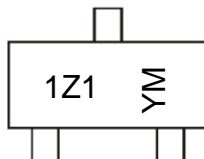


Device Schematic

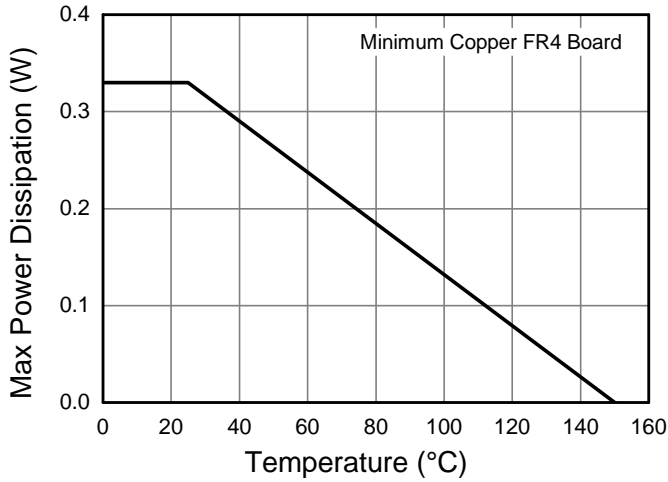

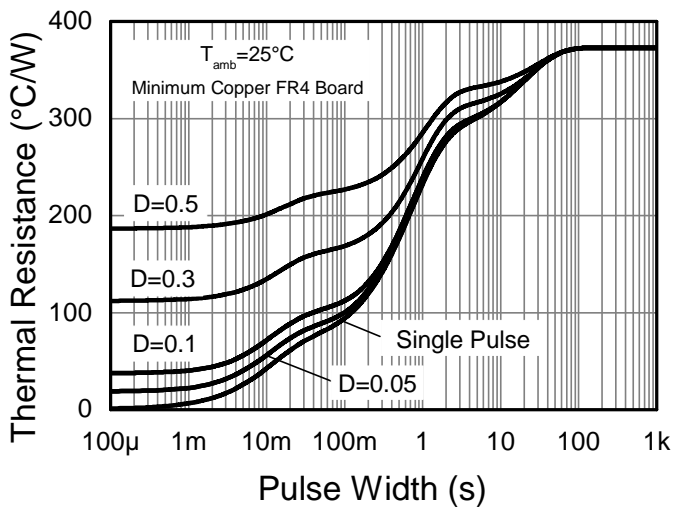

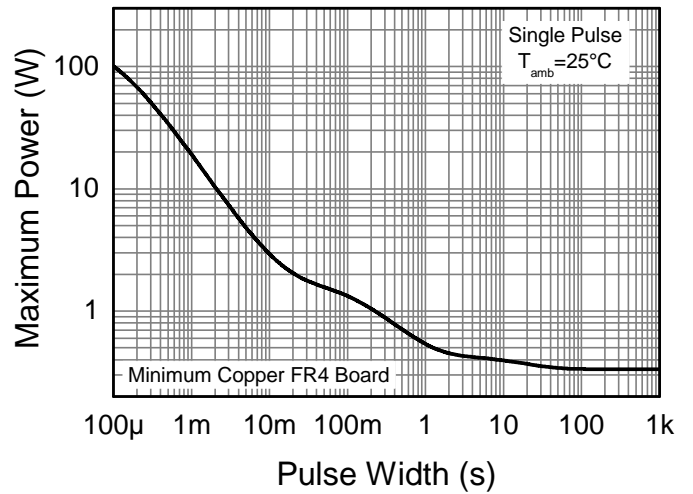

Transient Thermal Impedance

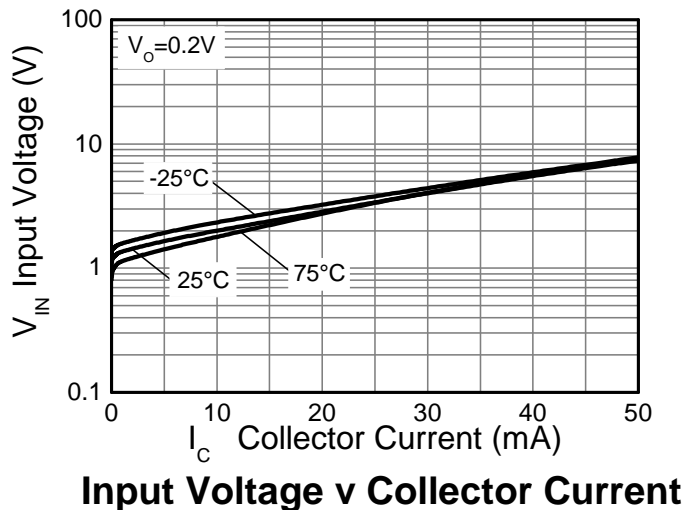
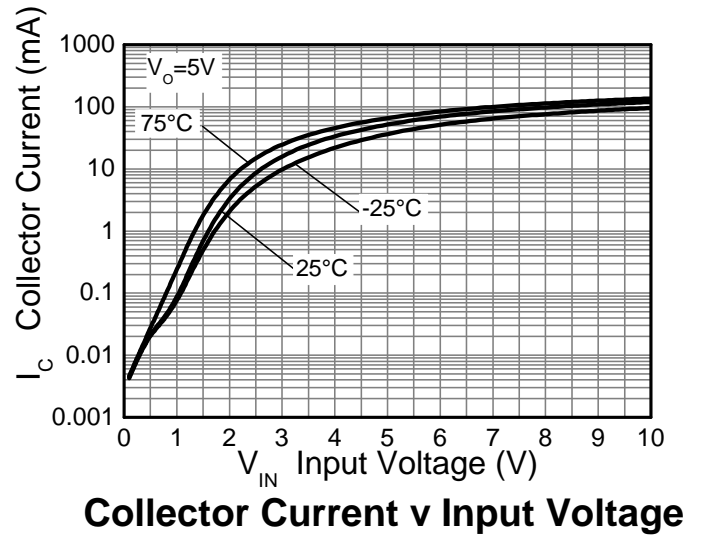
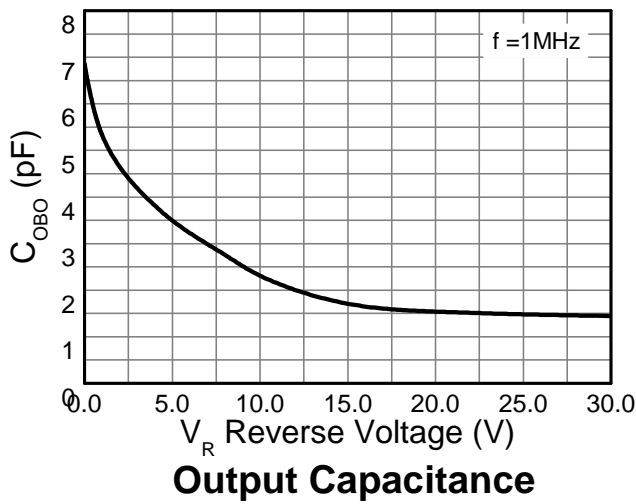
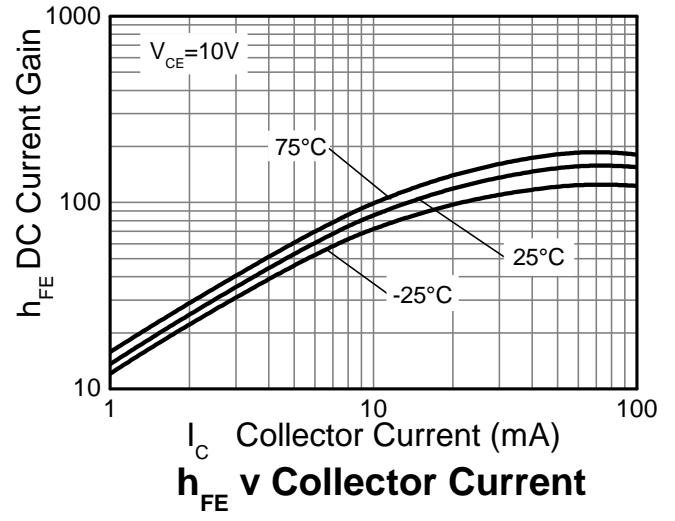
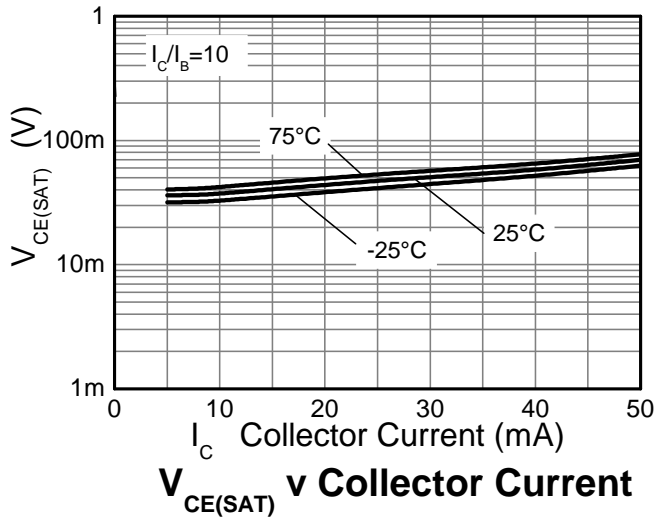
