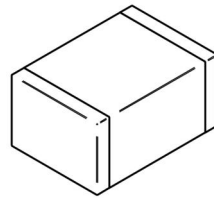

**F Derating Curve:**

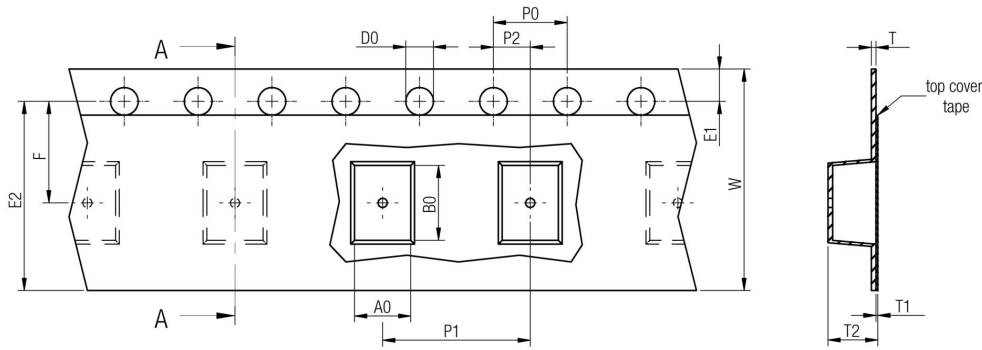

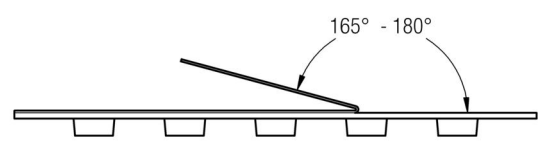


