## Steady State Power Dissipation Derating



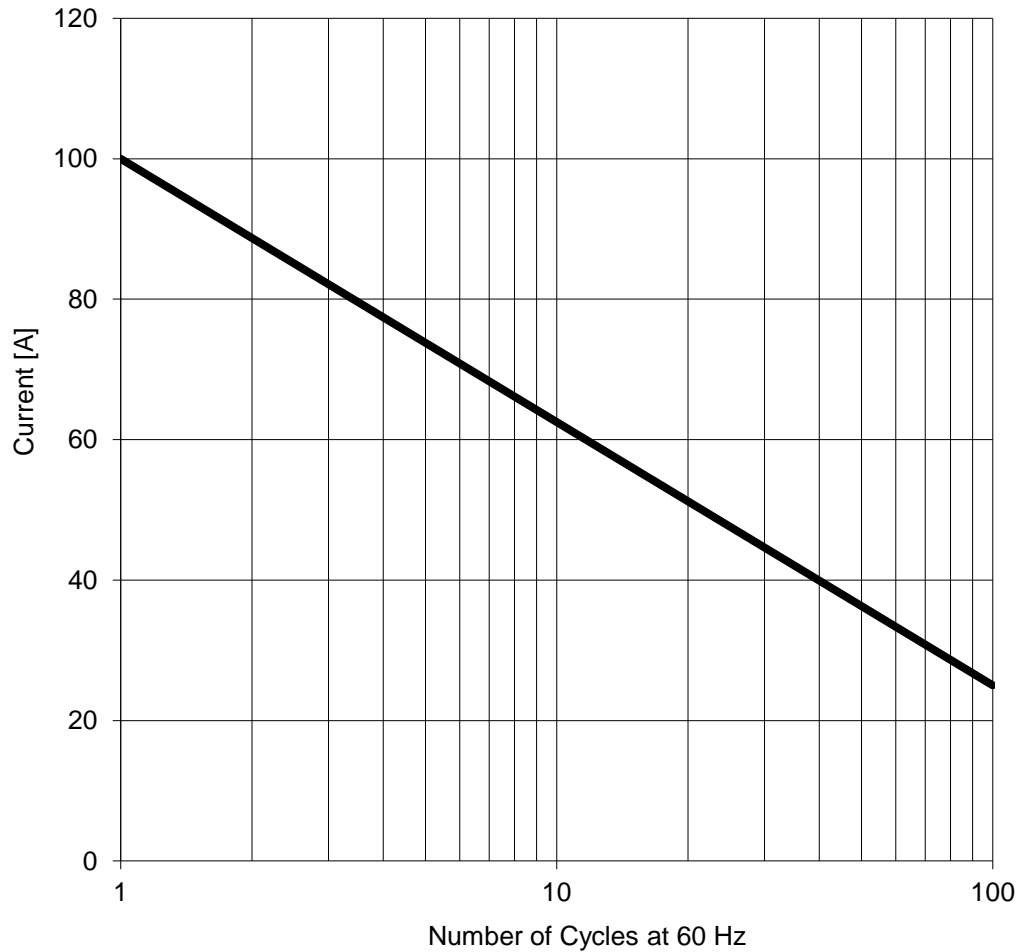

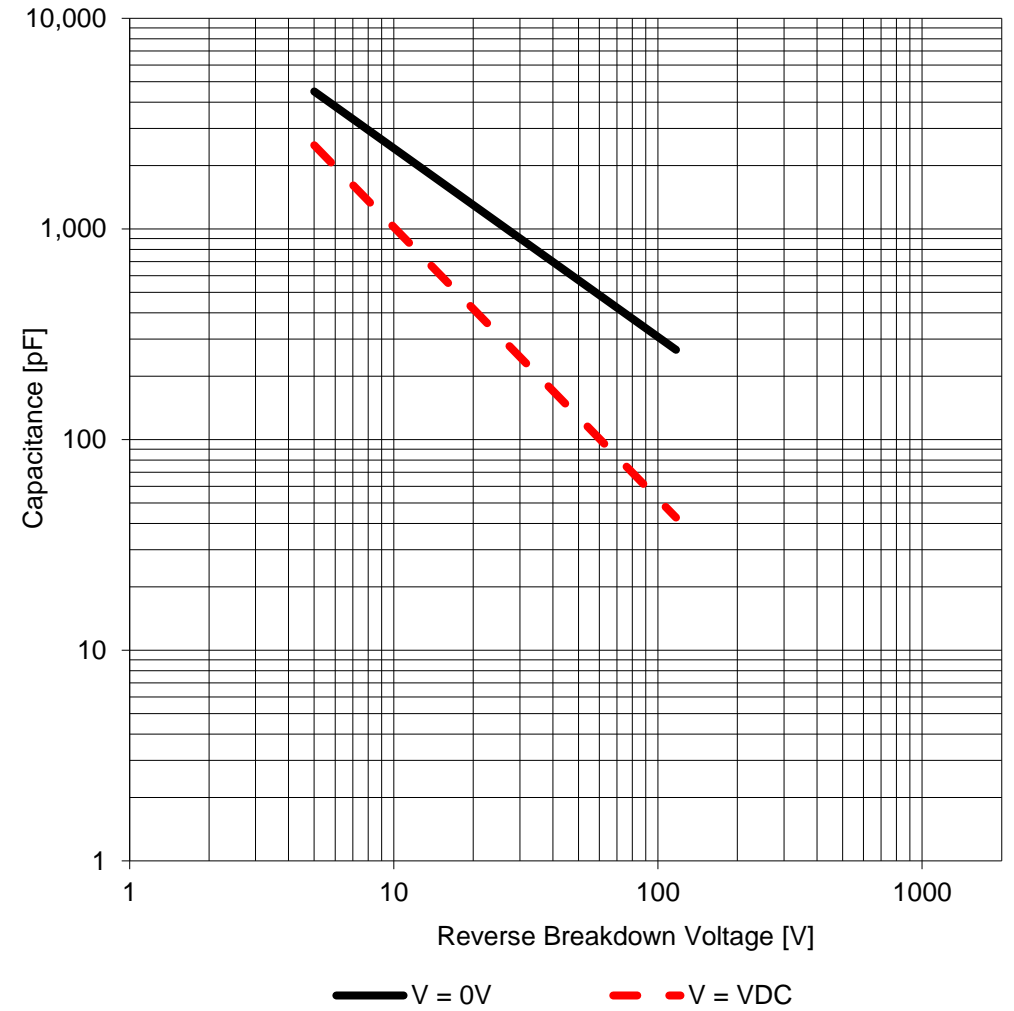

### Typical Junction Capacitance




