





## F1 Typical Inductance vs. Current Characteristics:




## **F2 Typical Inductance vs. Frequency Characteristics:**





## **F4 Typical Temperature Rise vs. Current Characteristics:**



If the product is potted in customer applications, the potting material might shrink during and after hardening. After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
- •Due to heavy weight of the component, strong forces and high accelerations might have the effect to damage the electrical connection or to harm the circuit board and will void the warranty.
