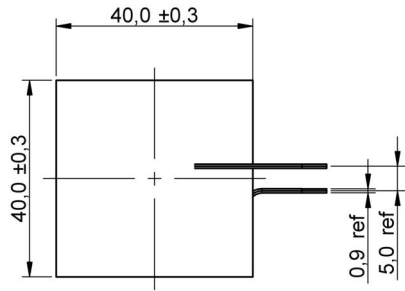

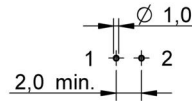

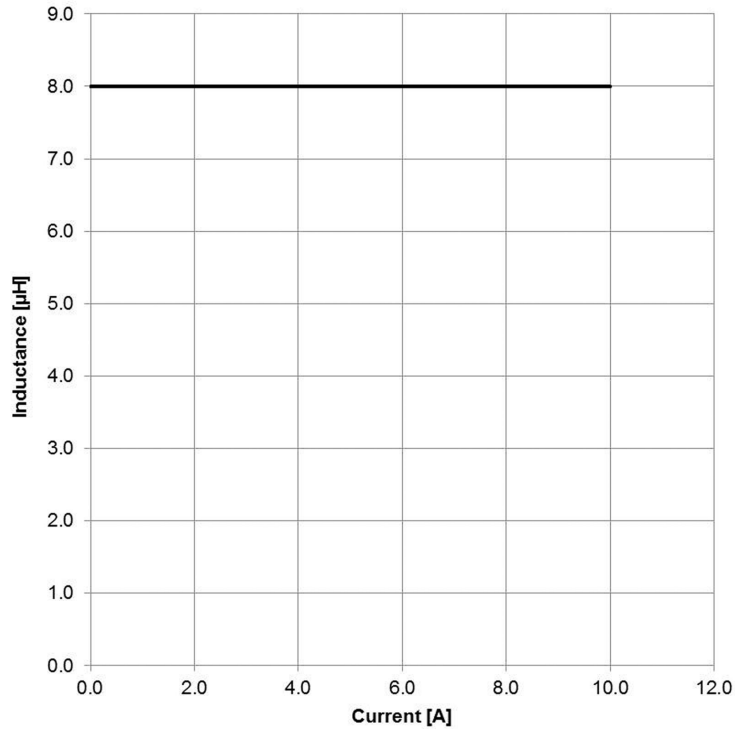

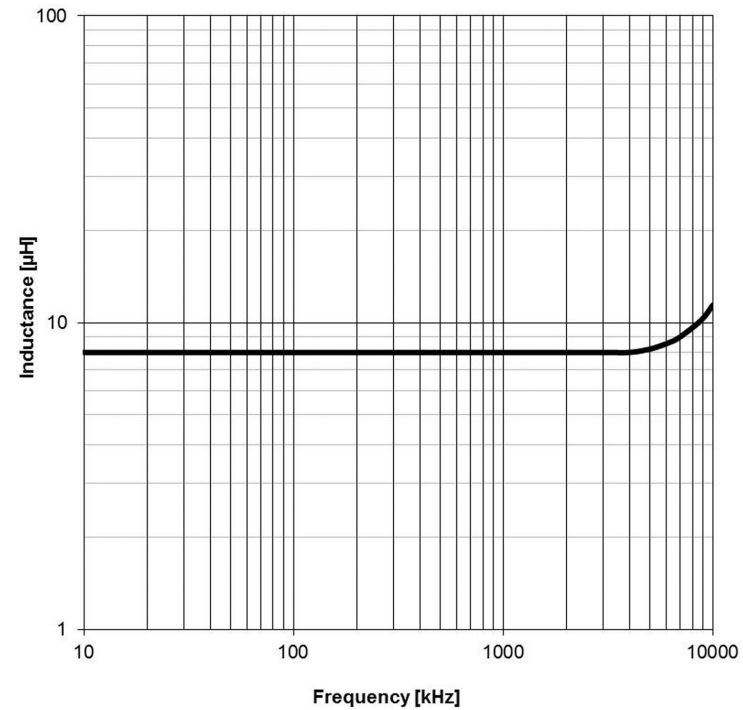

**F2 Typical Inductance vs. Frequency Characteristics:**

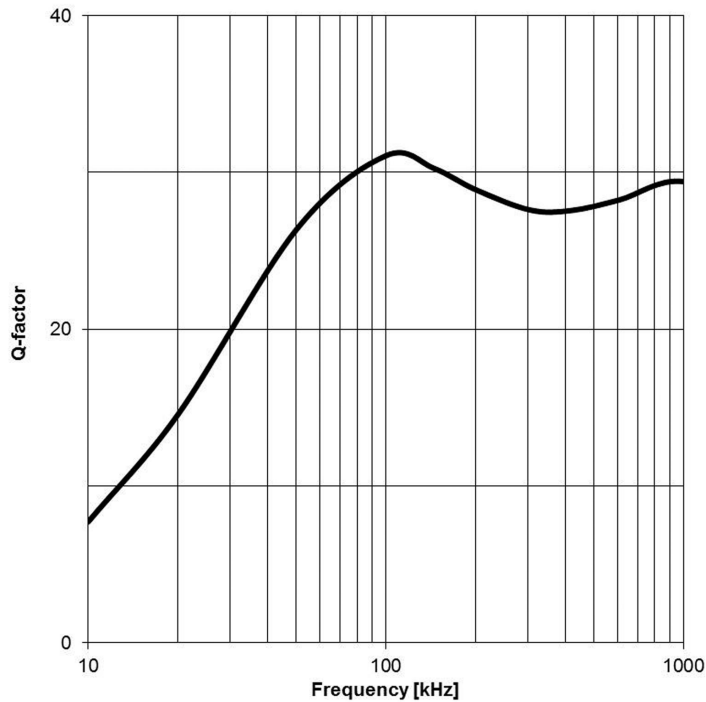

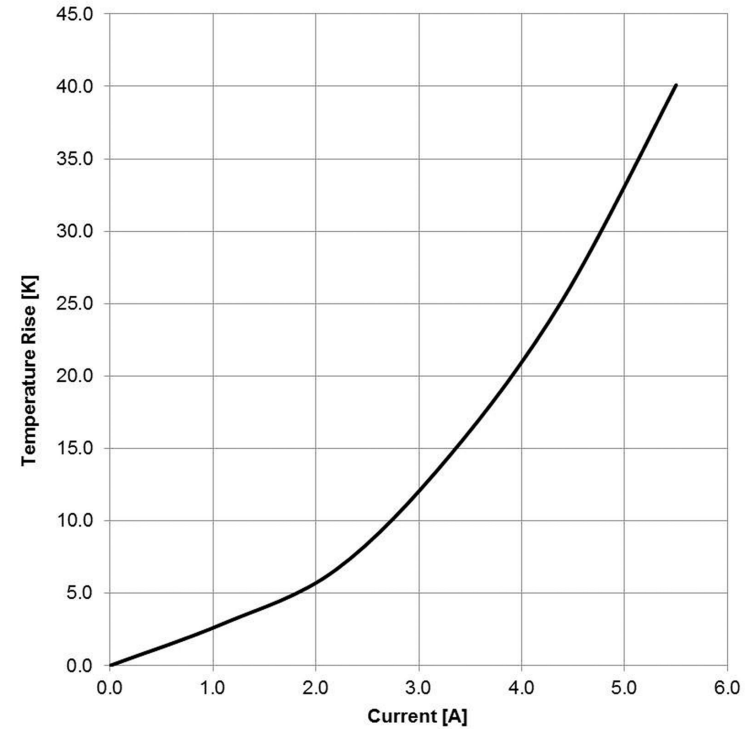
