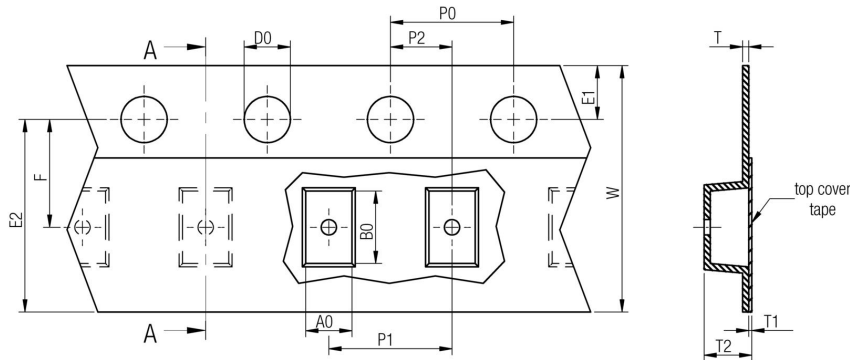
F Typical Differential Mode Insertion Loss Characteristics:



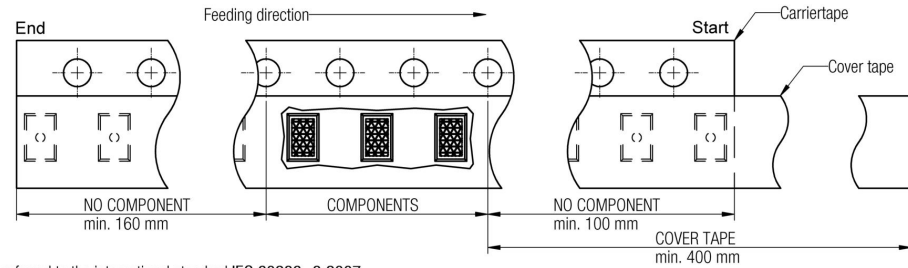
