


Fig. 1 Forward Power Dissipation




Fig. 2 Typical Forward Characteristics




Fig. 3 Typical Reverse Characteristics




Fig. 4 Typical Reverse Characteristics




Fig. 5 Typical Capacitance vs. Reverse Voltage




Fig. 6 Forward Current Derating Curve





Fig. 7 Operating Temperature Derating


