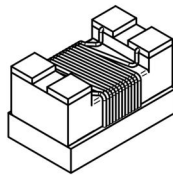

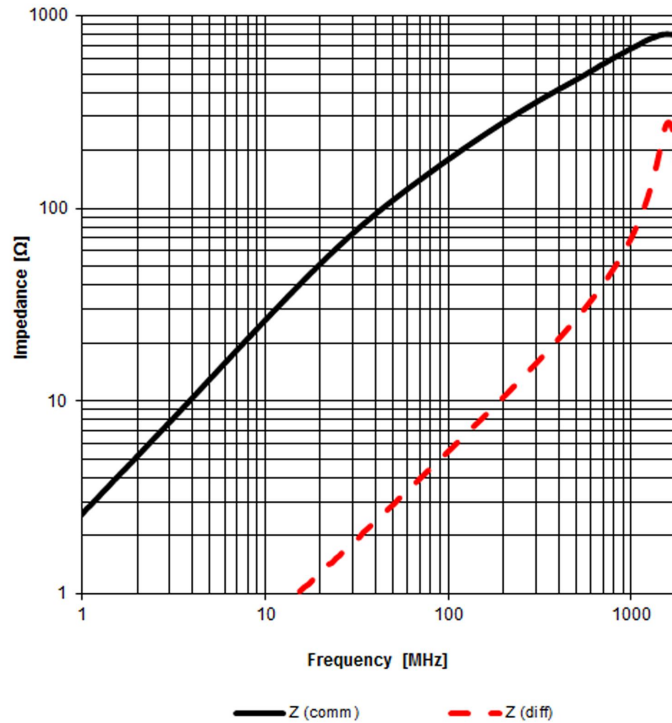

Common Mode

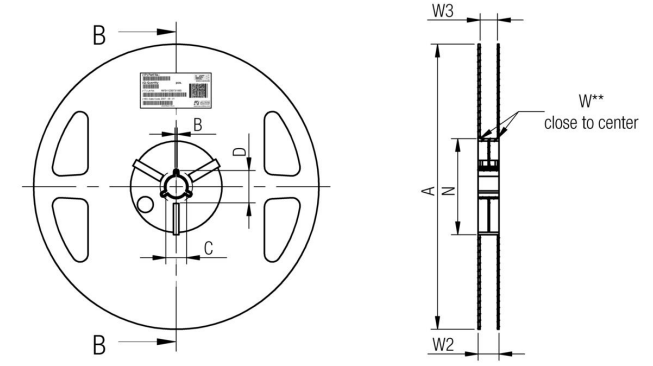


Differential Mode
