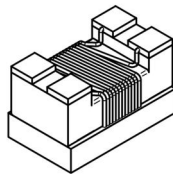

Differential Mode

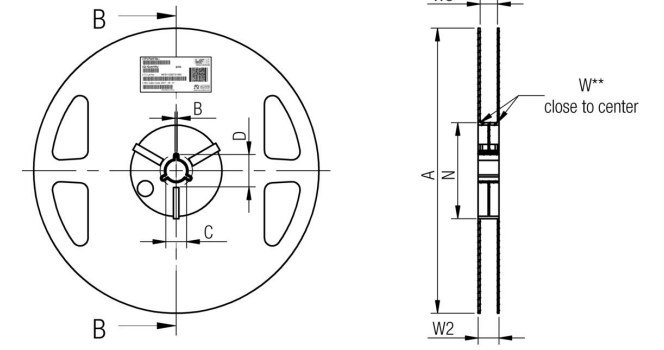
