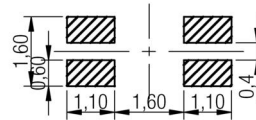

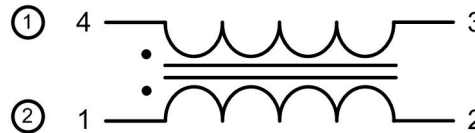

Common Mode

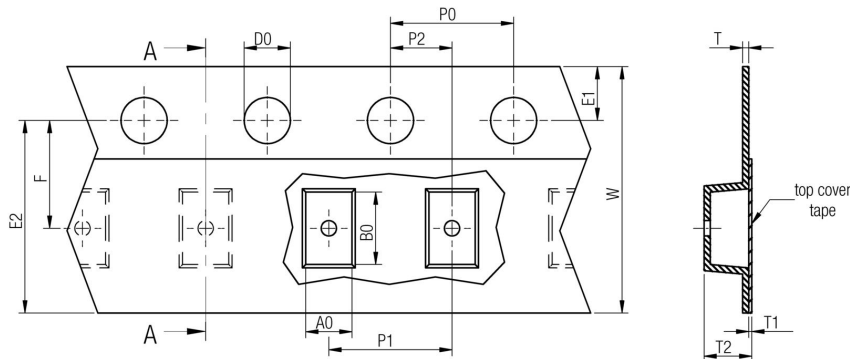


Differential Mode

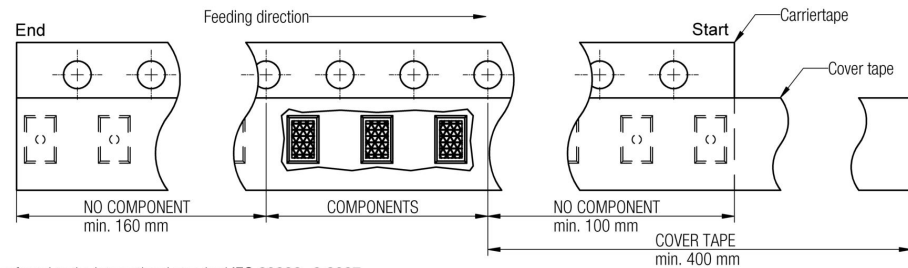
