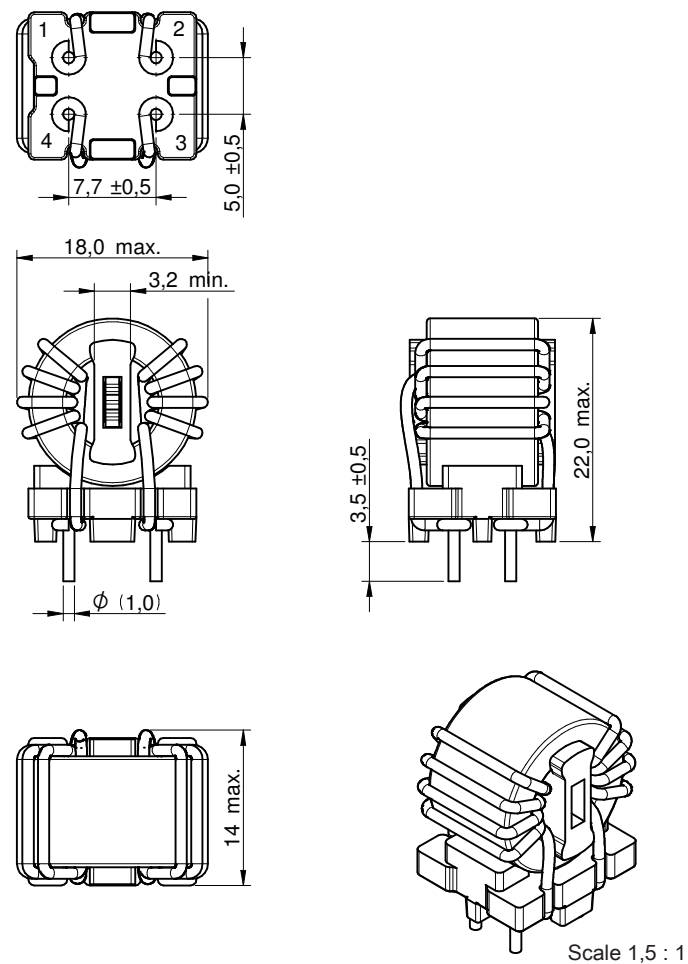
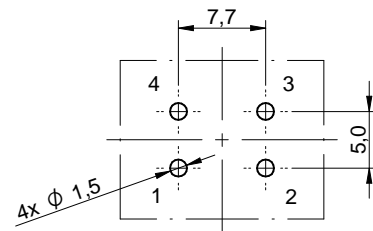

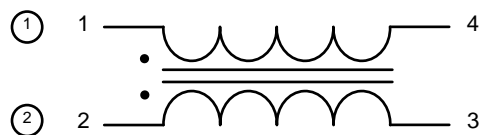


Recommended Hole Pattern: [mm]

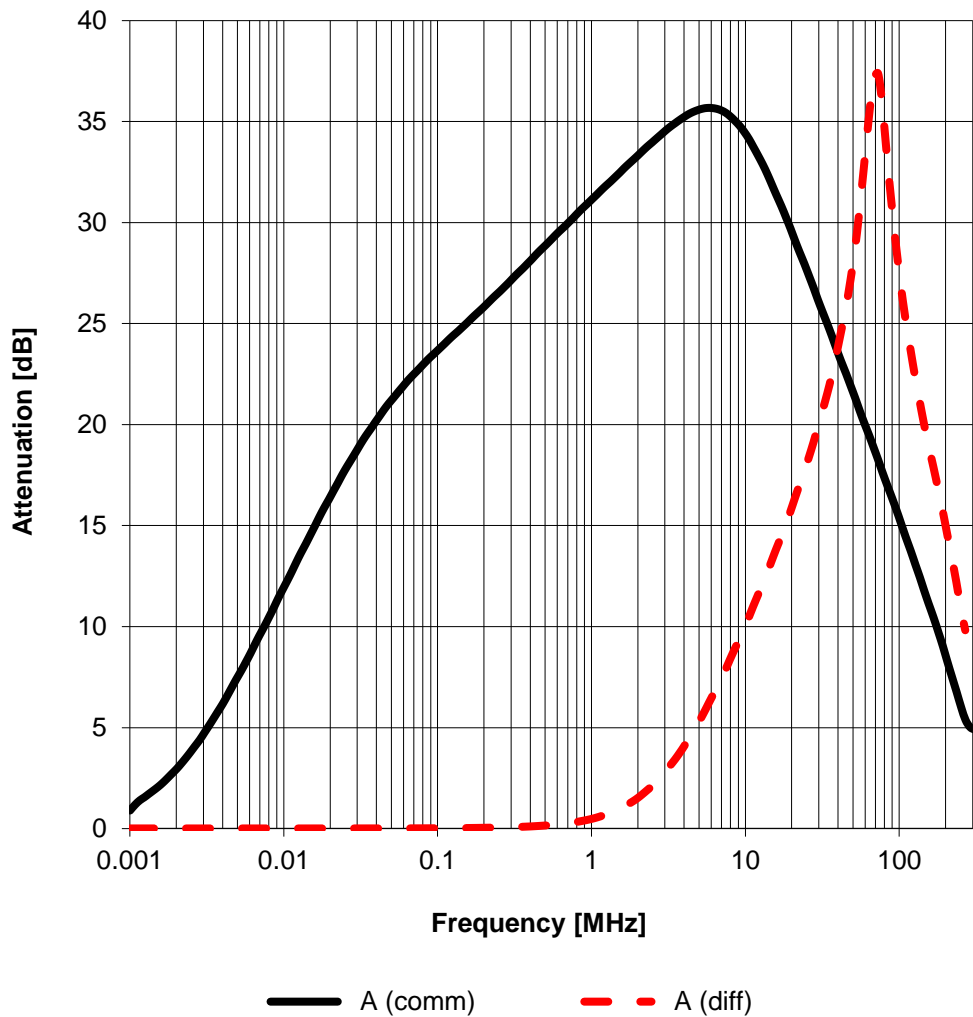

Typical Insertion Loss:



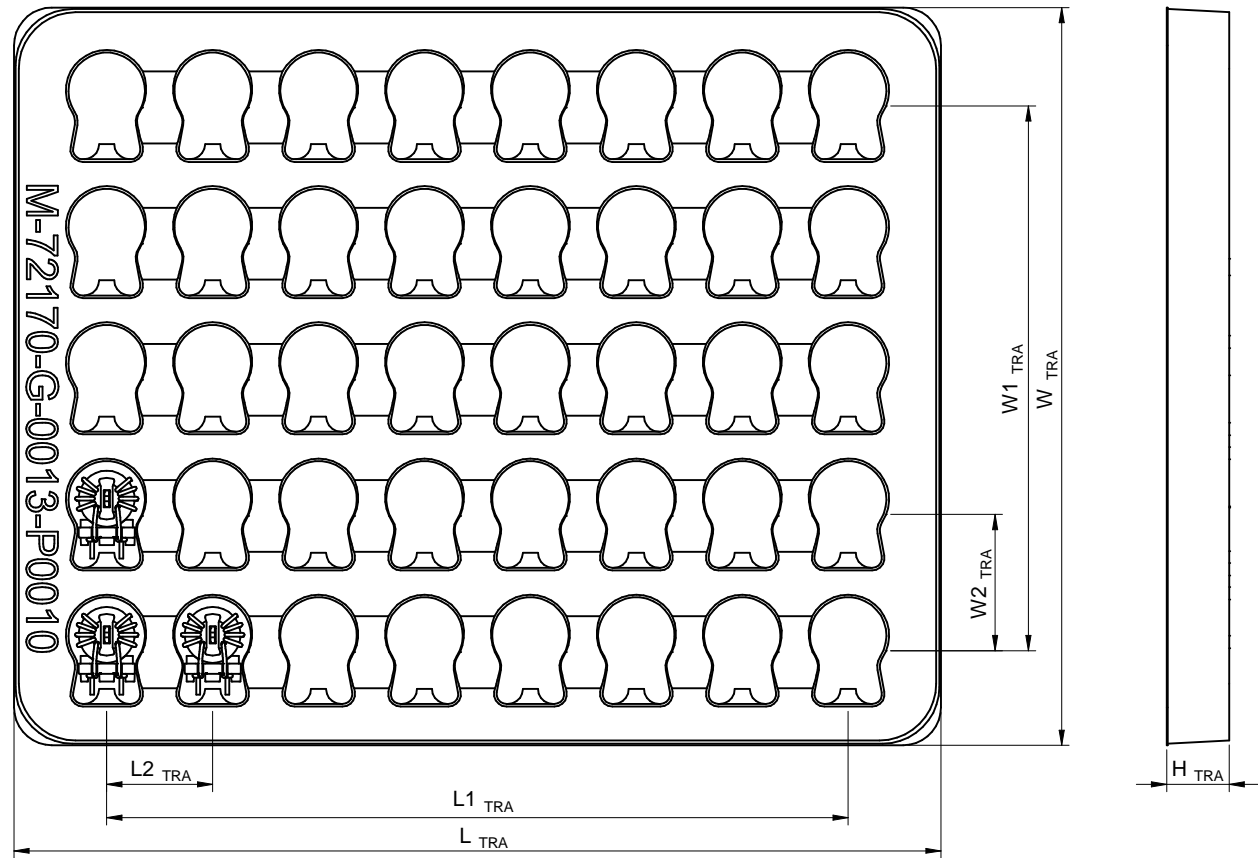


