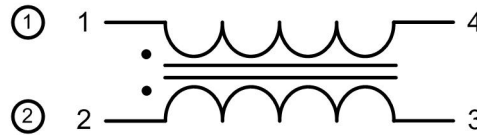

### F Typical Insertion Loss Characteristics:



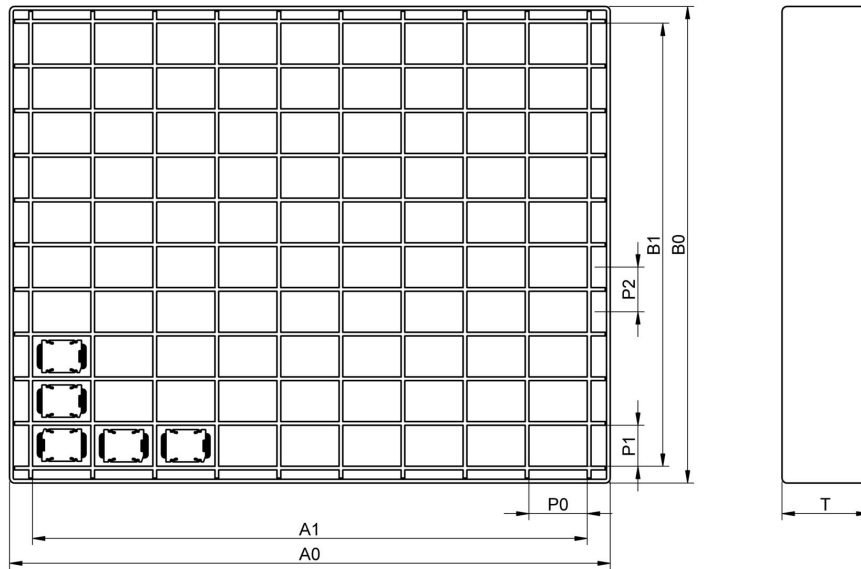

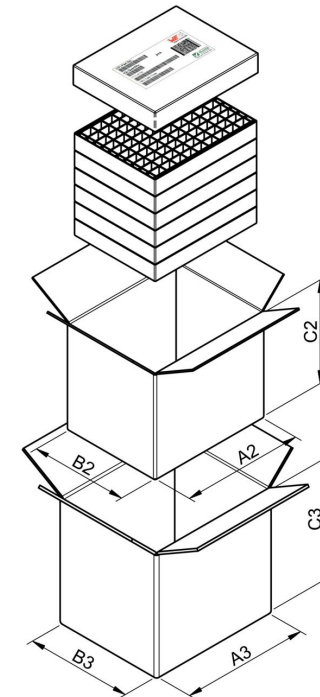

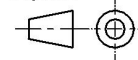

Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.



### Product specific:


