



**Fig. 1. Normalized total power dissipation as a function of mounting base temperature**



$$T_{mb} = 25^\circ\text{C}; I_{DM} \text{ is a single pulse}$$




Fig. 4. Avalanche rating; avalanche current as a function of avalanche time





Fig. 5. Transient thermal impedance from junction to mounting base as a function of pulse duration






**Fig. 10. Sub-threshold drain current as a function of gate-source voltage**



**Fig. 13. Gate charge waveform definitions**




Fig. 14. Gate-source voltage as a function of gate charge; typical values

$T_j = 25^\circ\text{C}$ ;  $I_D = 25\text{A}$




Fig. 15. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values

$T_j = 25^\circ\text{C}$ ;  $I_D = 25\text{A}$




Fig. 16. Source (diode forward) current as a function of source-drain (diode forward) voltage; typical values




Fig. 17. Package outline LFPAK56; Power-SO8 (SOT669)
