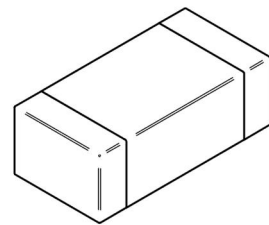

F Derating Curve:



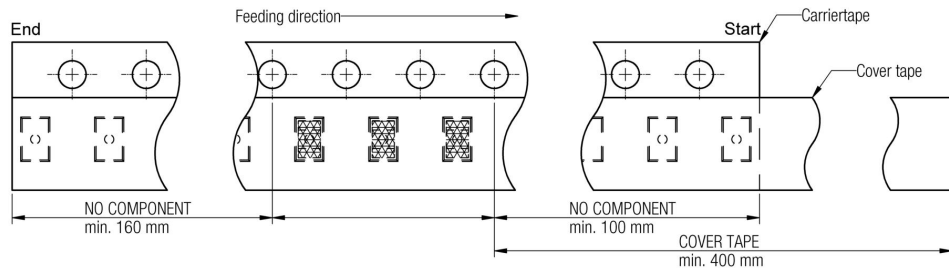
