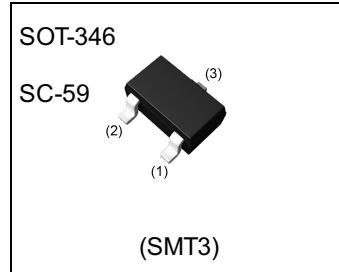
### ●Features

- 2) The bias resistors consist of thin-film resistors with complete isolation to allow negative

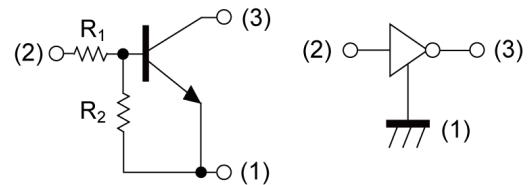
biasing of the input. They also have the advantage of almost completely eliminating parasitic effects.

Fig.1 Input Voltage vs. Output Current (ON Characteristics)

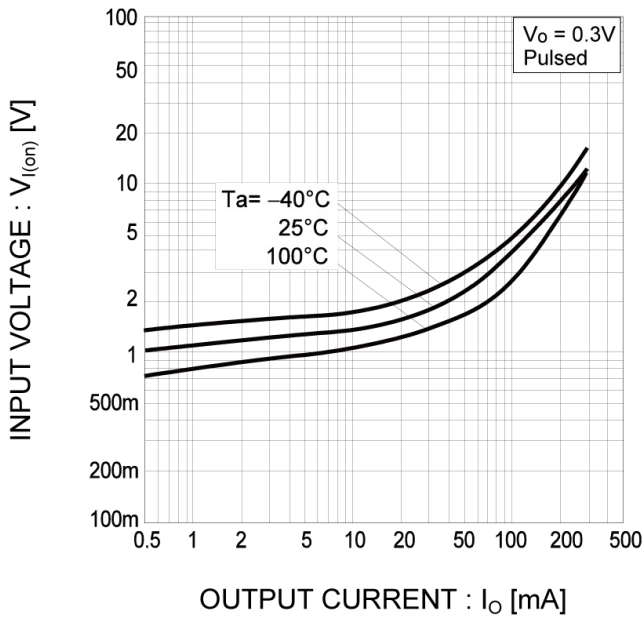


Fig.2 Output Current vs. Input Voltage (OFF Characteristics)

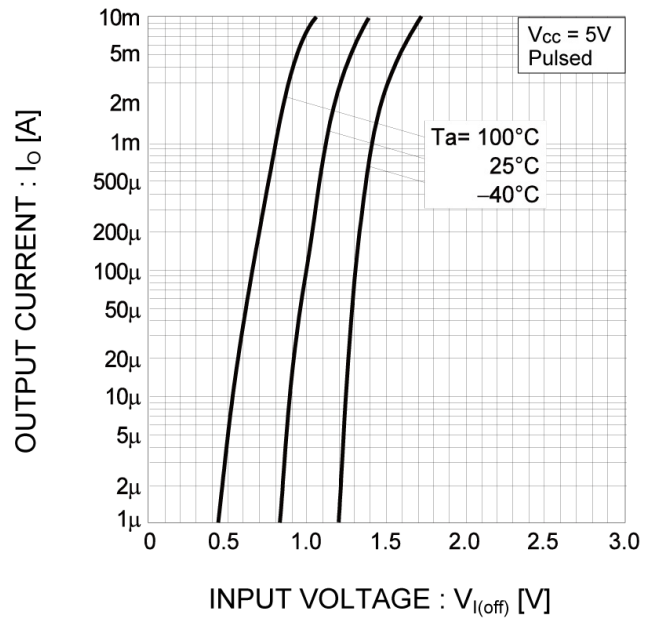


Fig.3 Output Current vs. Output Voltage

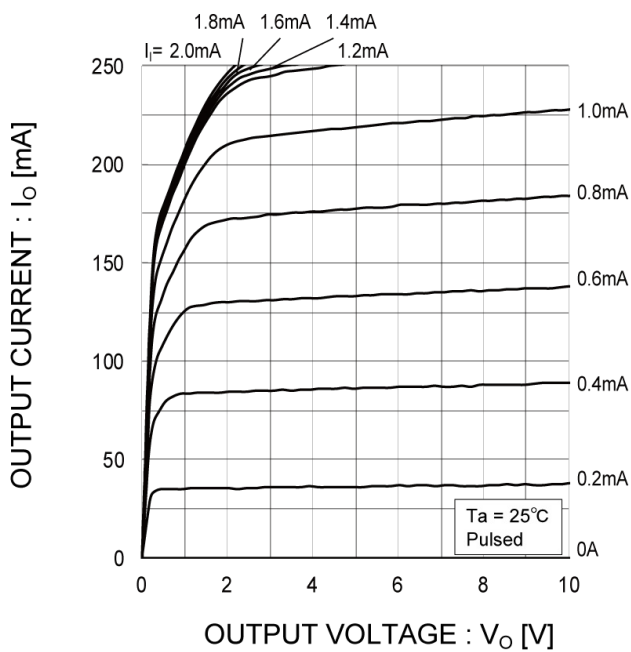
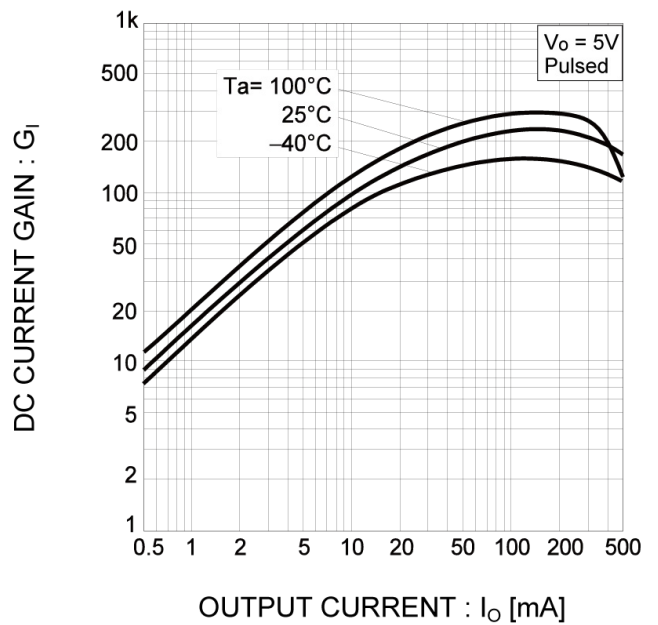
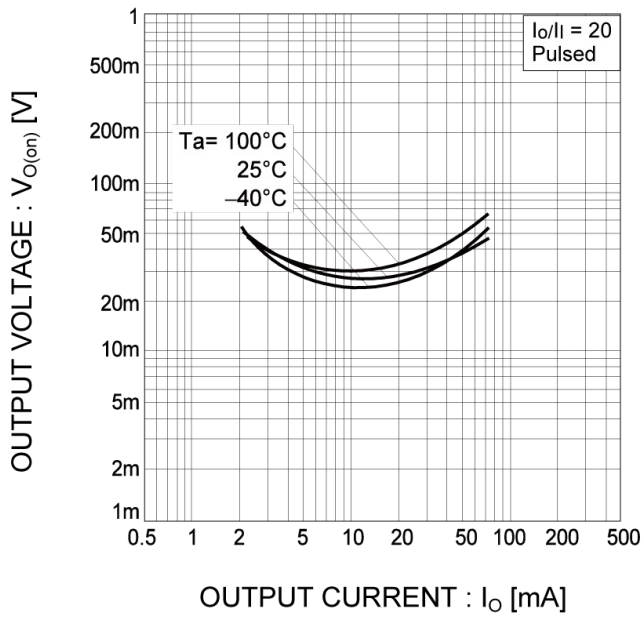


Fig.4 DC Current Gain vs. Output Current



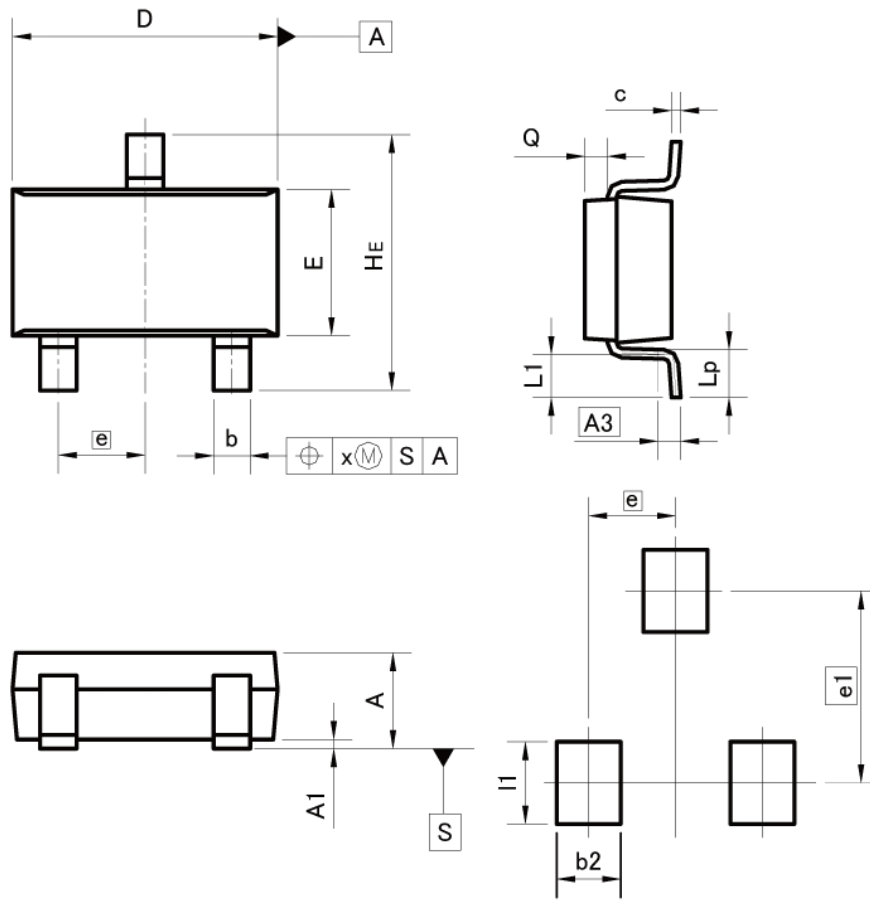
● Electrical characteristic curves ( $T_a = 25^\circ\text{C}$ )
