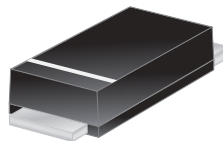

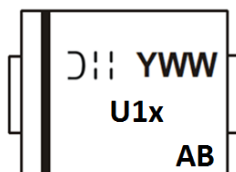

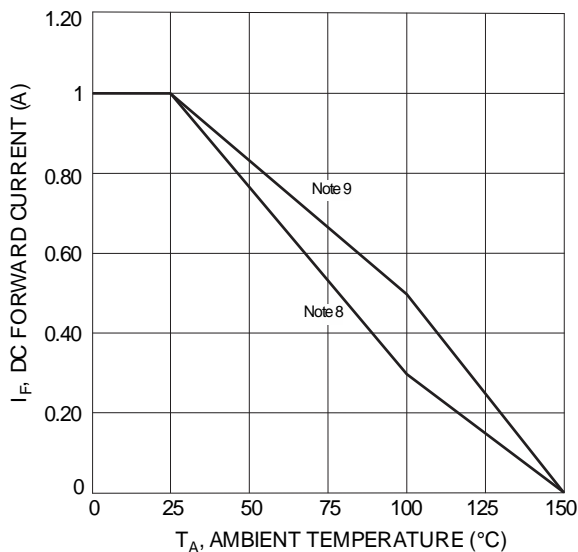


Figure 1 Forward Current Derating

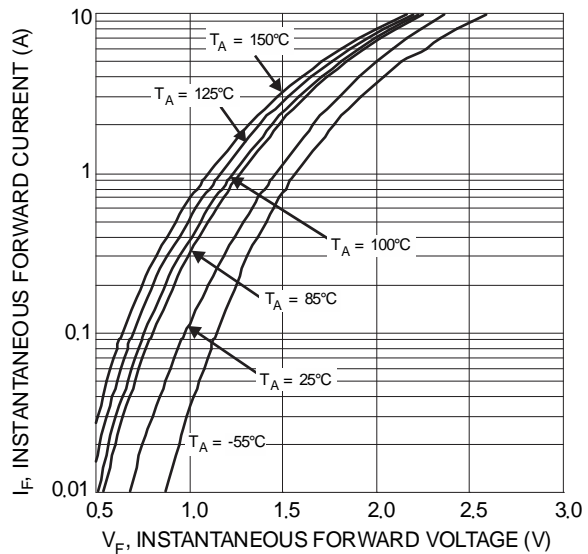


Figure 2 Typical Forward Characteristics

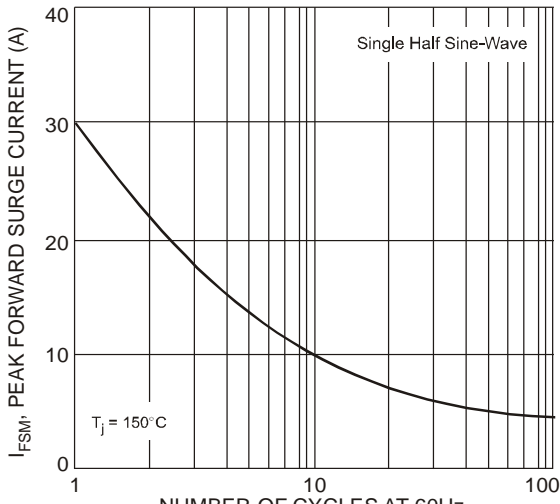


Fig. 3 Forward Surge Current Derating Curve

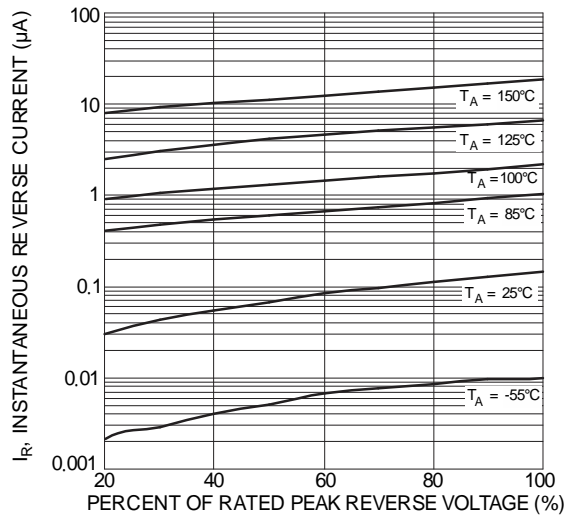


Figure 4 Typical Reverse Characteristics

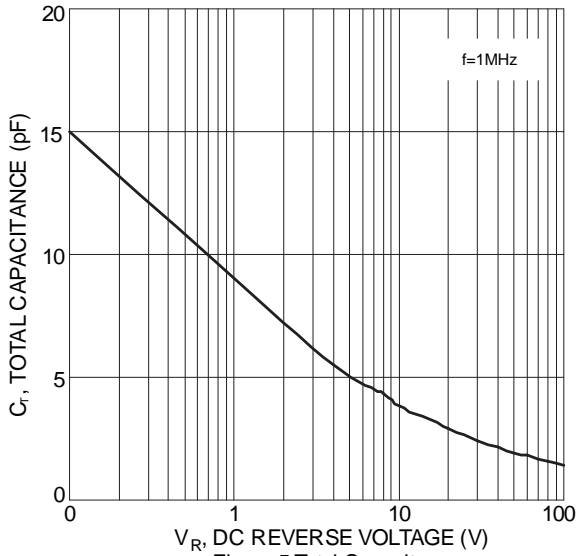


Figure 5 Total Capacitance

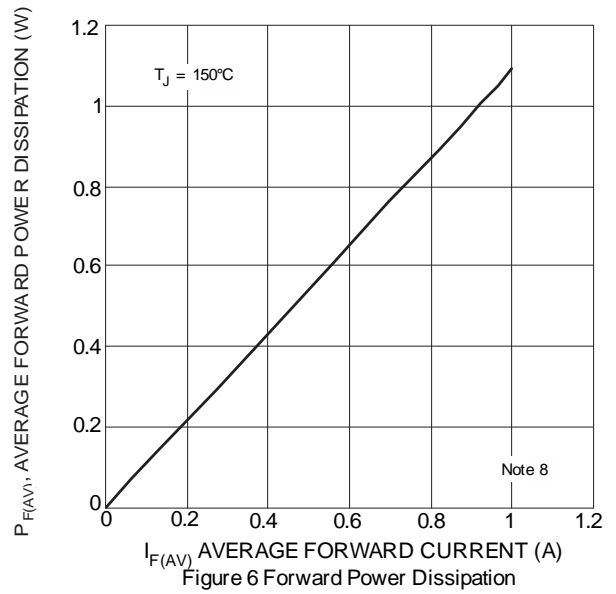
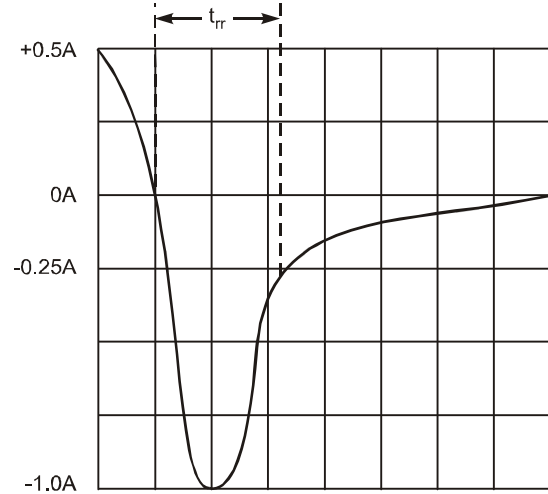
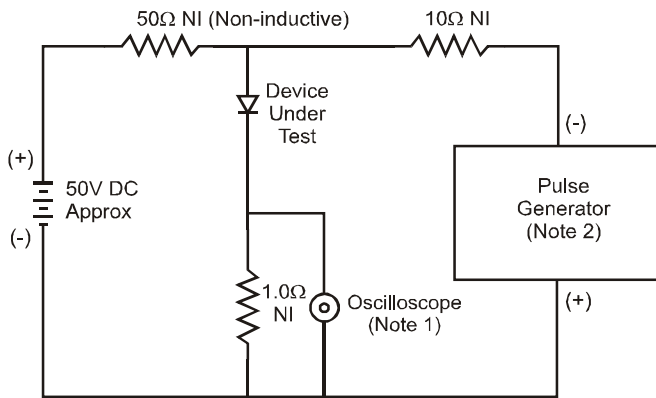


Figure 6 Forward Power Dissipation



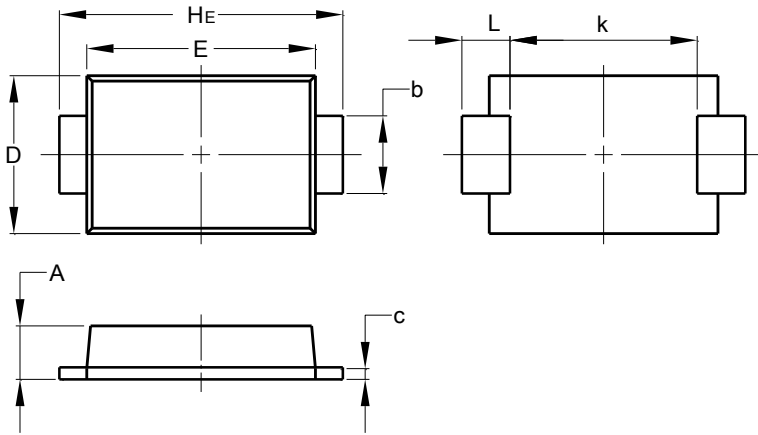

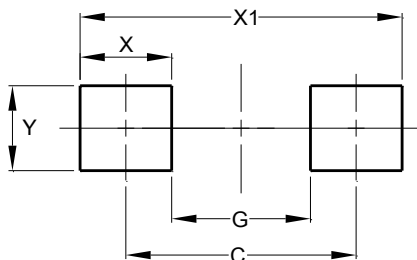
