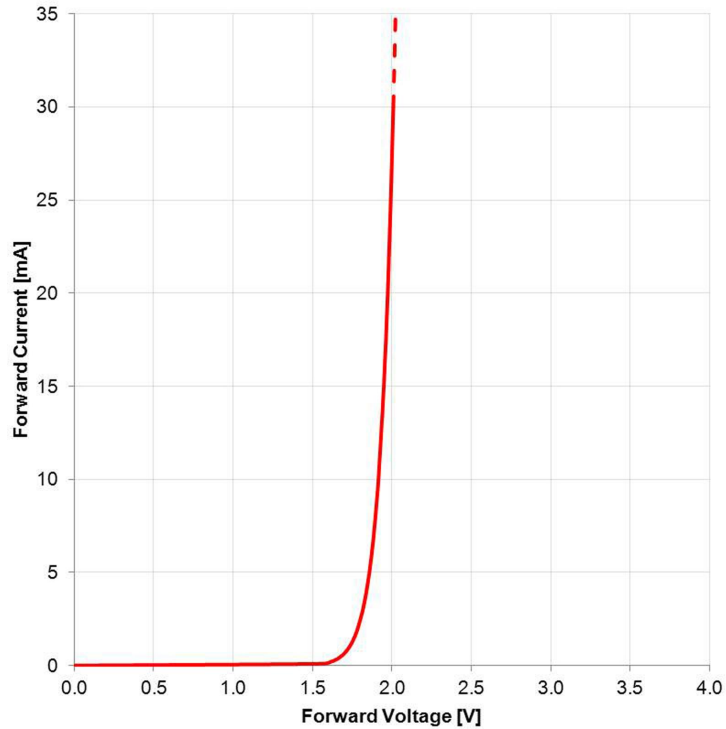

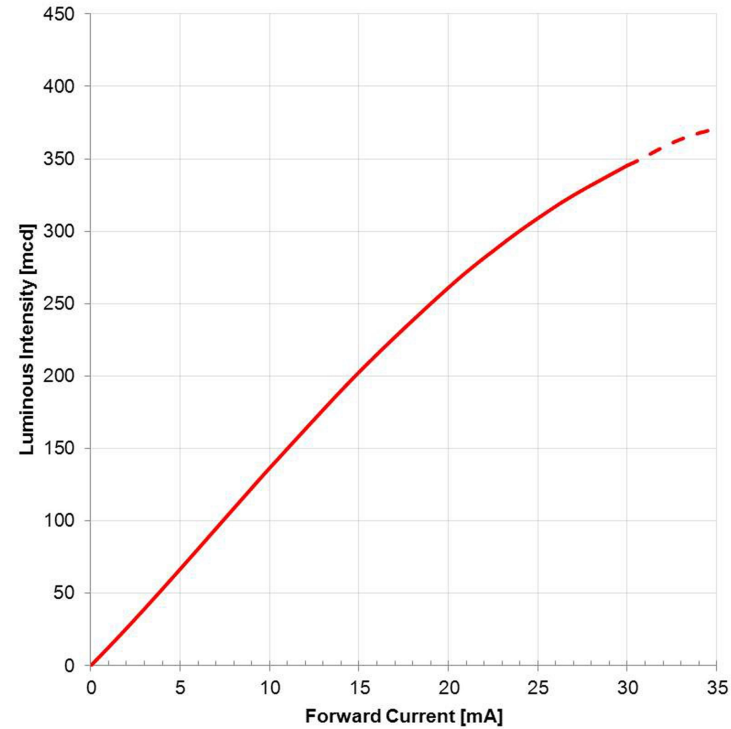

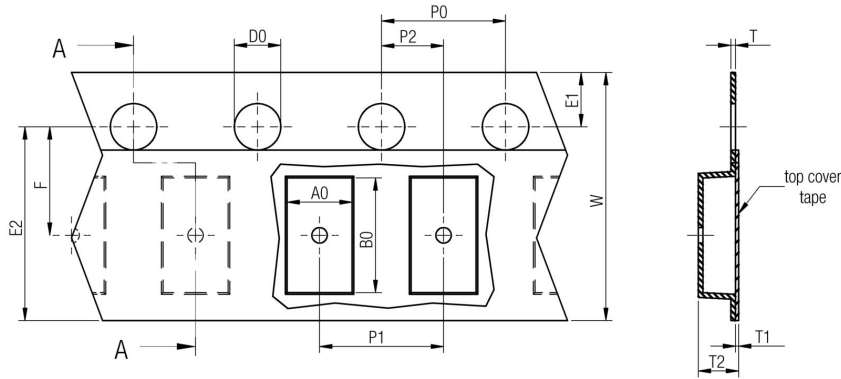
F5 Derating Curve:



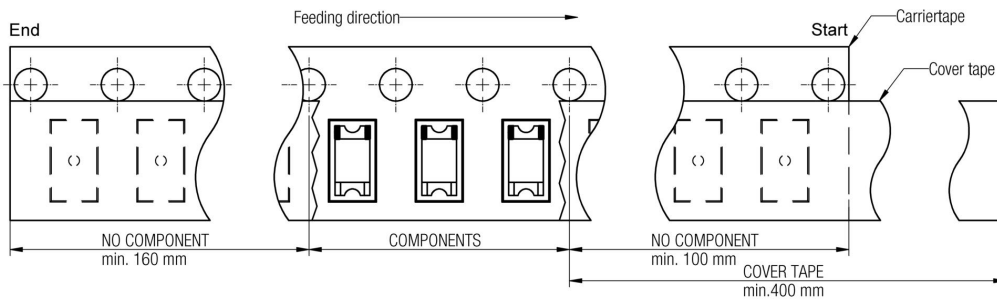


