

### **DESCRIPTION/ORDERING INFORMATION**

The SN74LVC1G332 performs the Boolean function in Y = A + B + C or  $Y = \overline{A} \bullet \overline{B} \bullet \overline{C}$  positive logic.

NanoStar™ and NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using  $I_{off}$ . The  $I_{off}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.







Figure 1. Load Circuit and Voltage Waveforms






