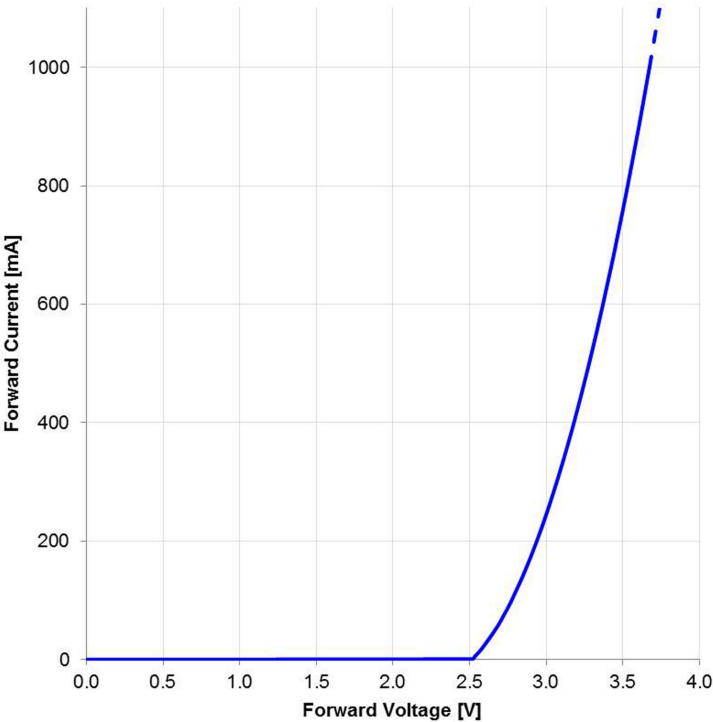

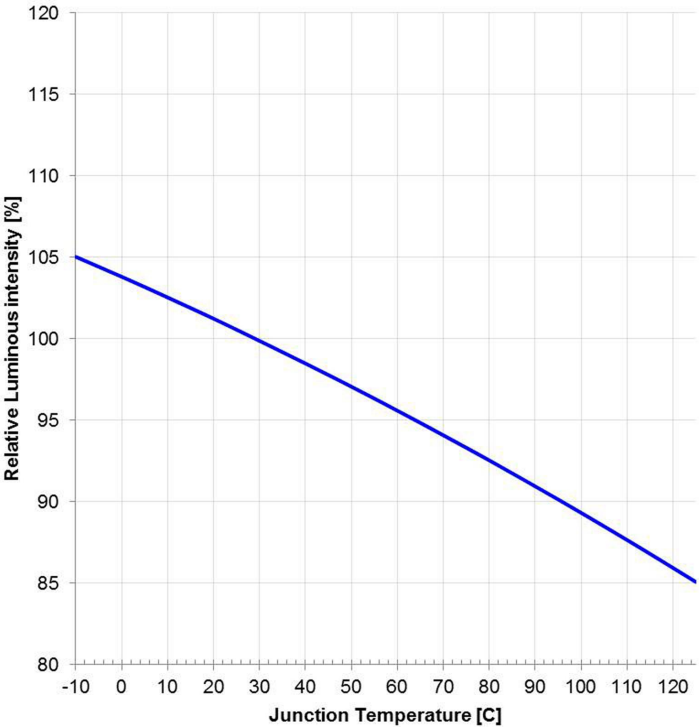

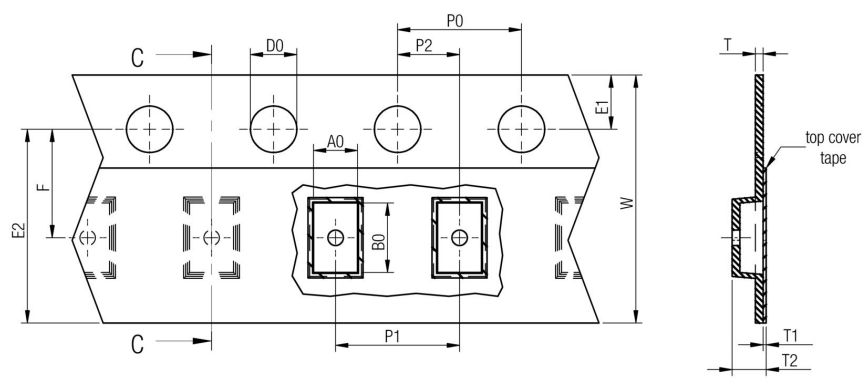
F7 Derating Curve:



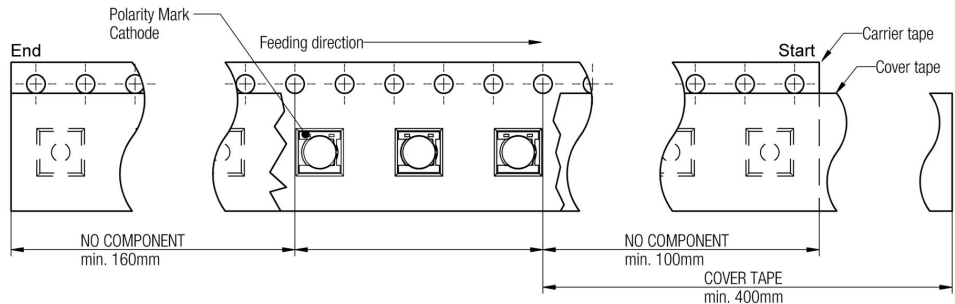
