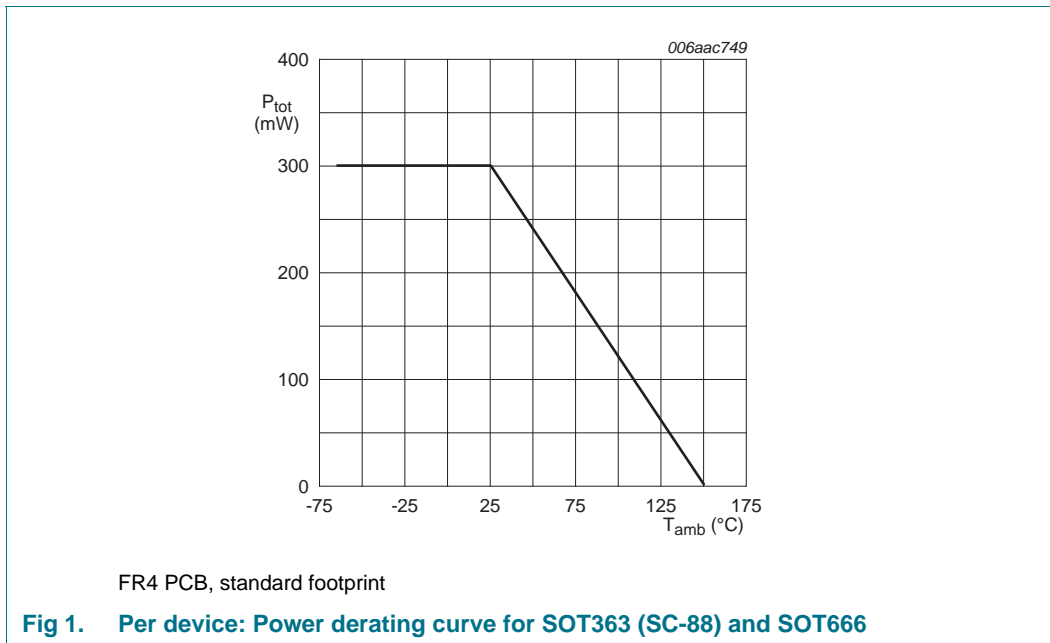

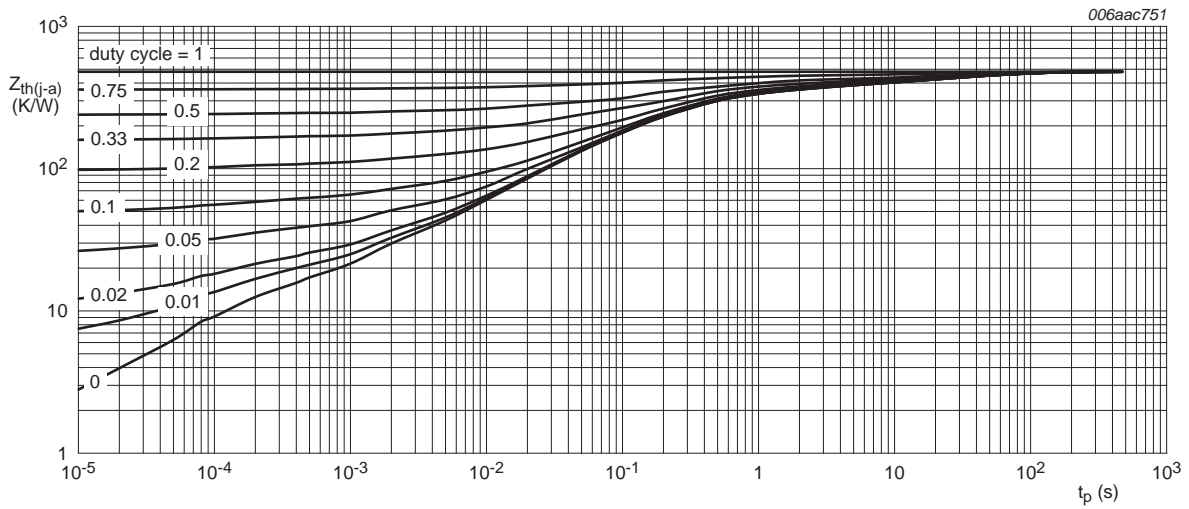

Fig 3. Per transistor: Transient thermal impedance from junction to ambient as a function of pulse duration for PUMB15 (SOT363); typical values

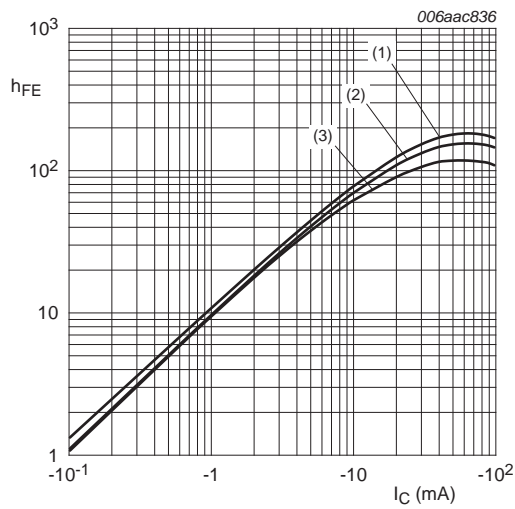

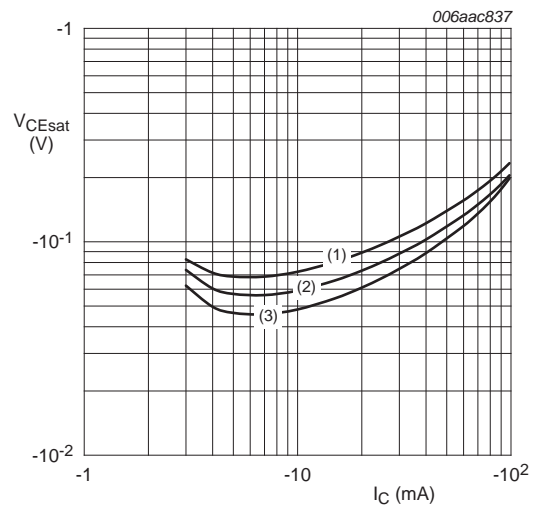

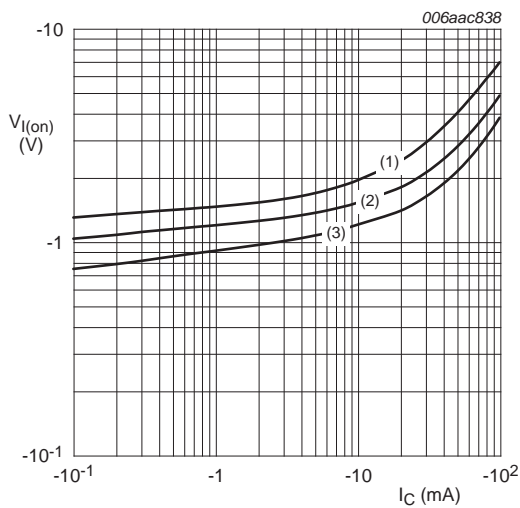

Fig 4. DC current gain as a function of collector current; typical values



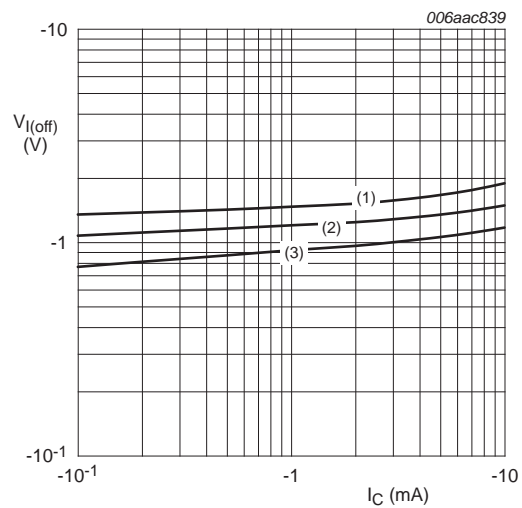

Fig 5. Collector-emitter saturation voltage as a function of collector current; typical values



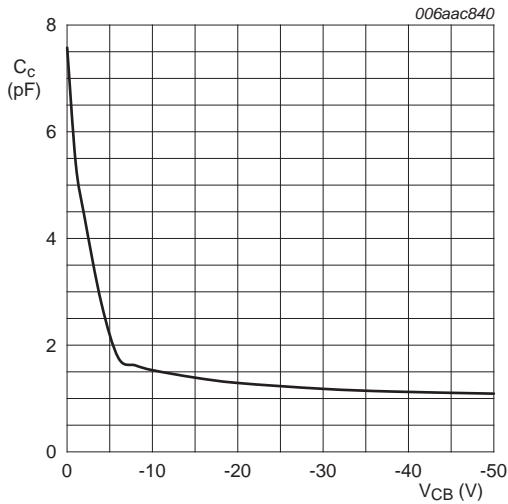

Fig 6. On-state input voltage as a function of collector current; typical values



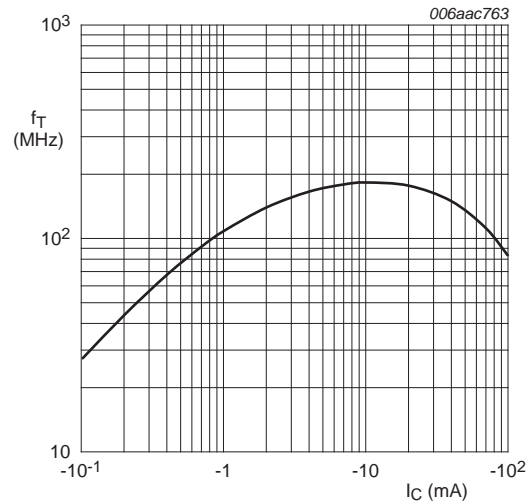

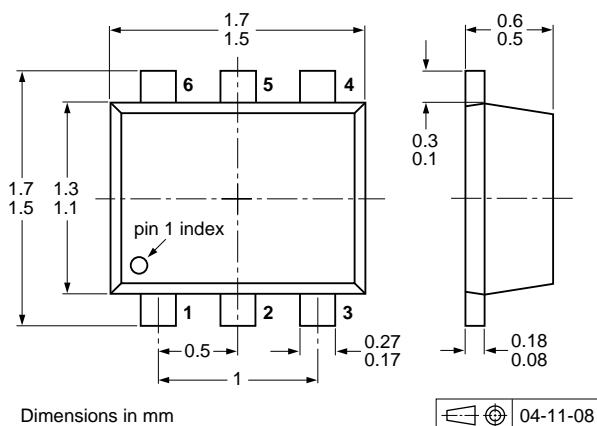


Fig 10. Package outline PEMB15 (SOT666)

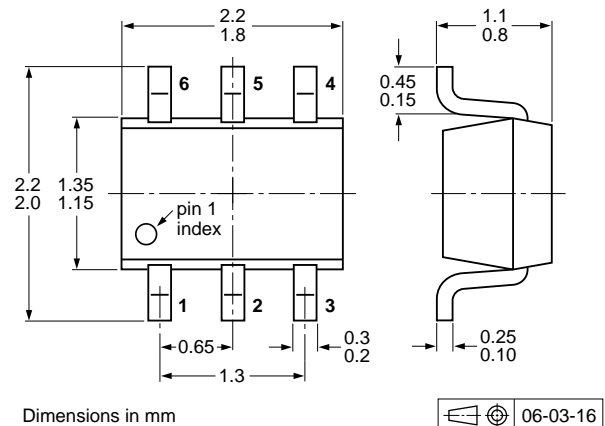


Fig 11. Package outline PUMB15 (SOT363)

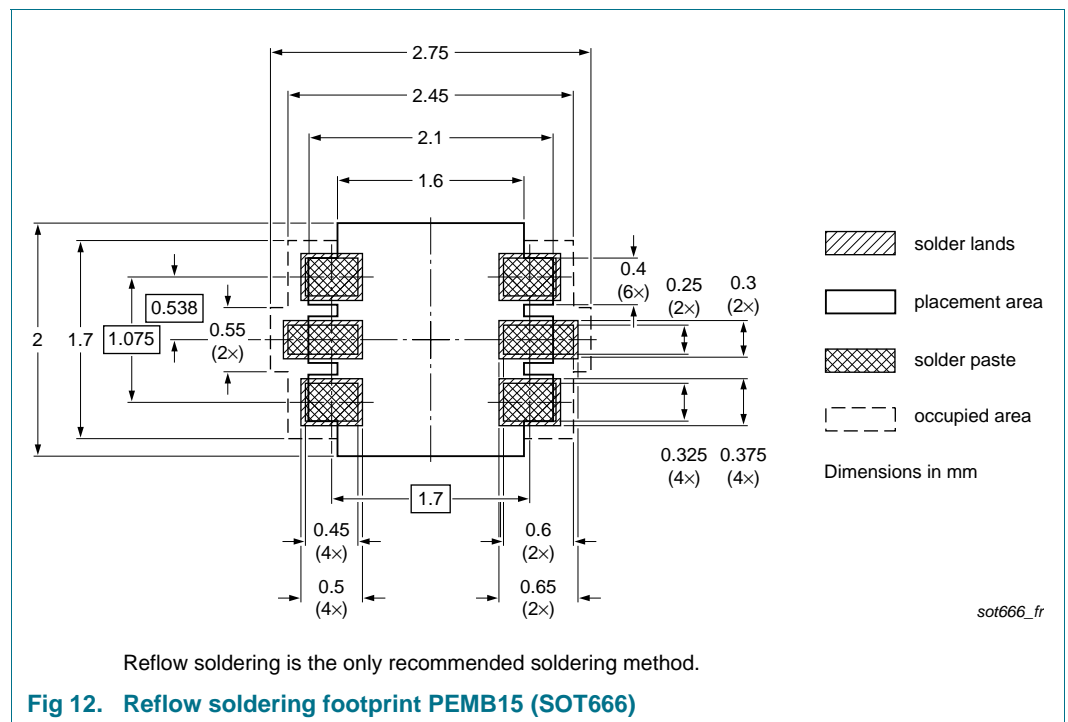

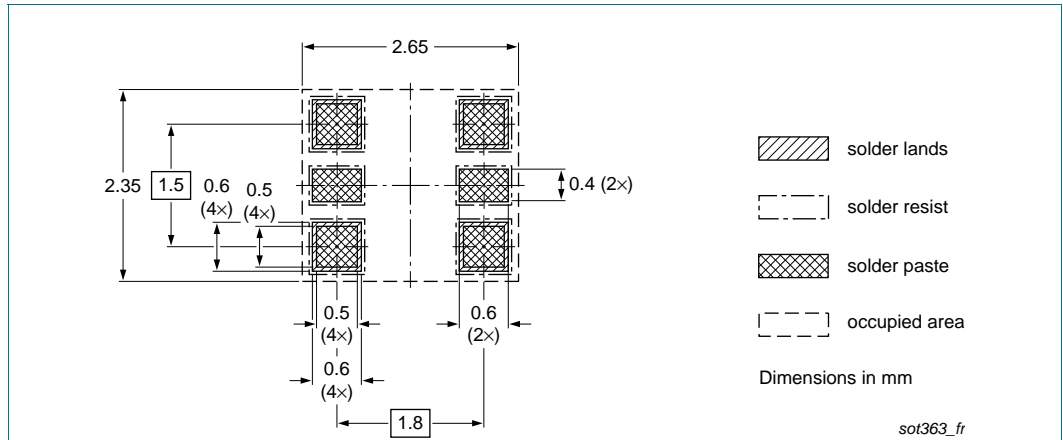


Fig 13. Reflow soldering footprint PUMB15 (SOT363)

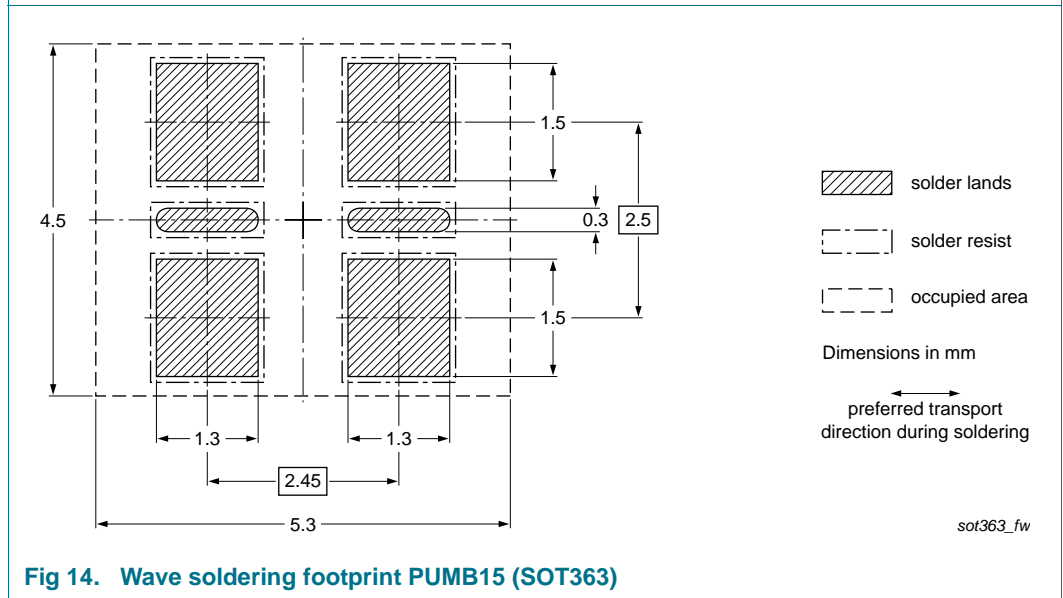


Fig 14. Wave soldering footprint PUMB15 (SOT363)
