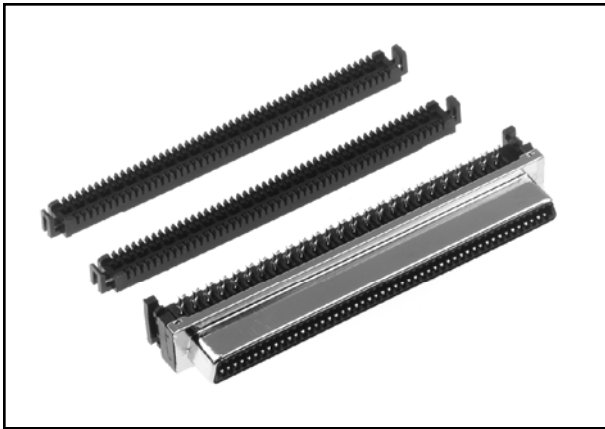

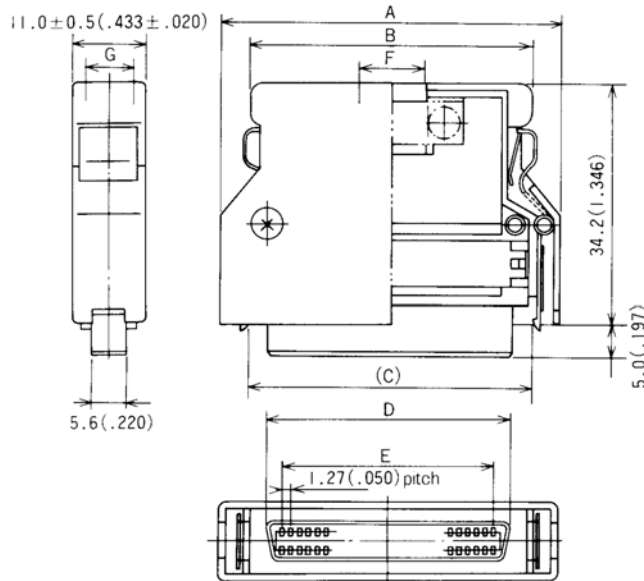

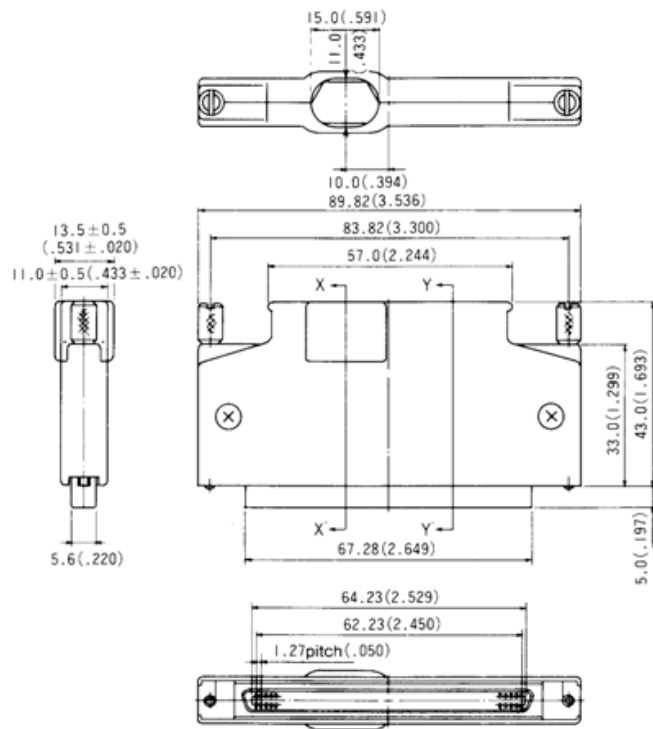

Y-Y Cross Section

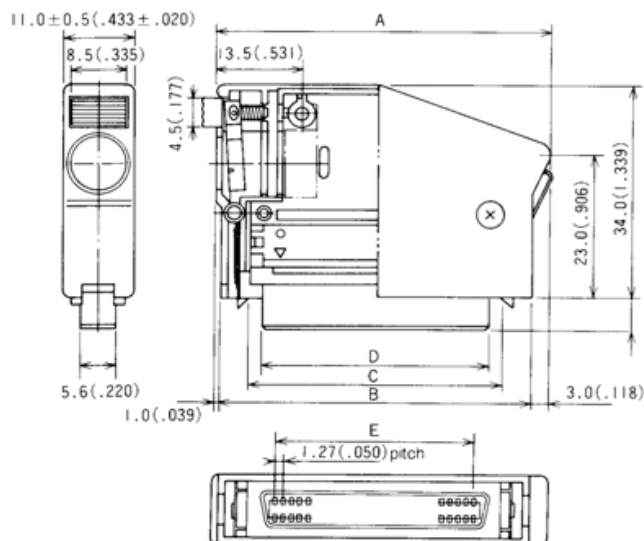
