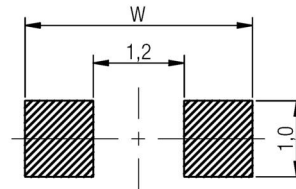

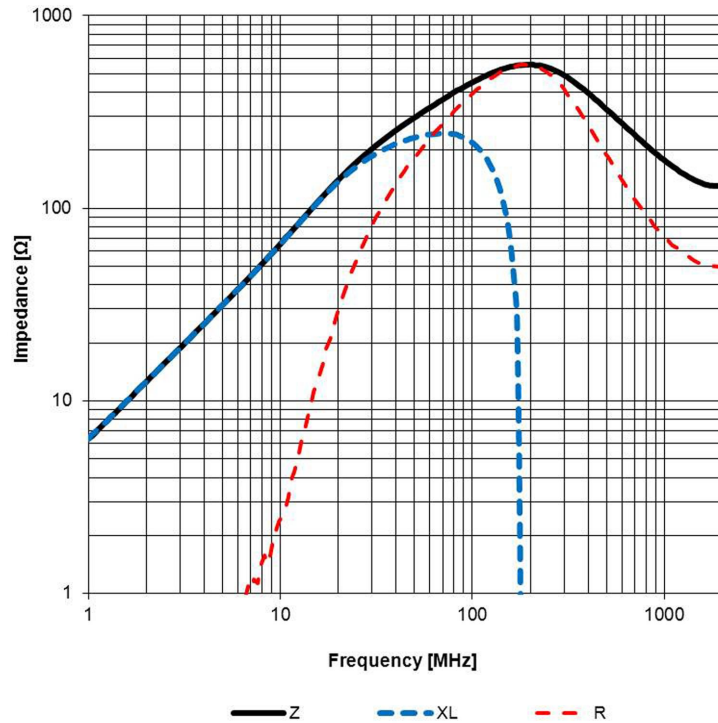

F Derating Curve:



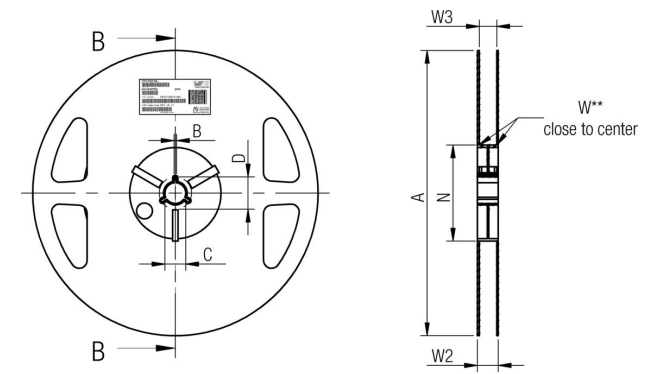
