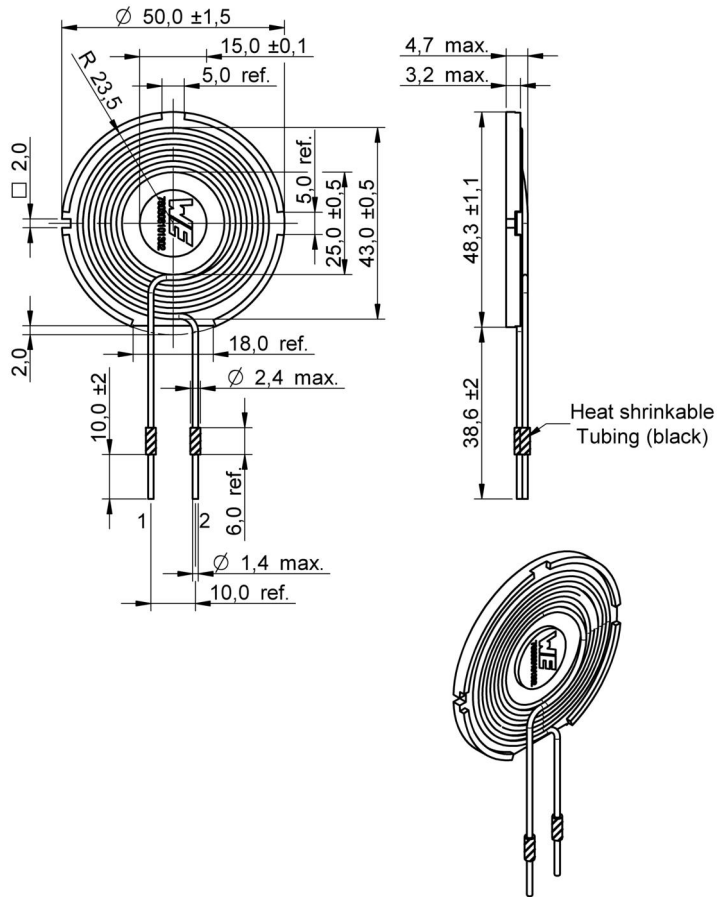
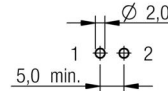


**A Dimensions: [mm]**

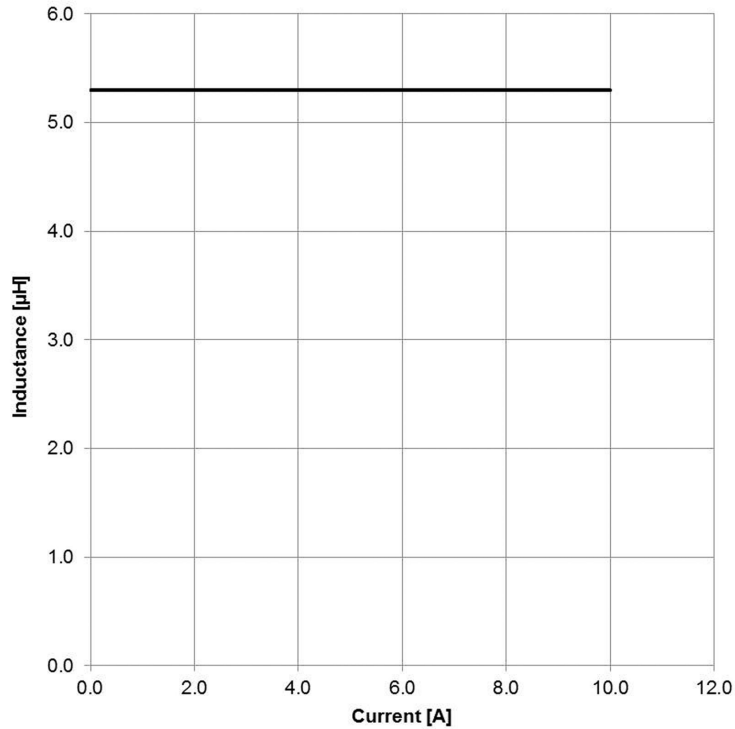

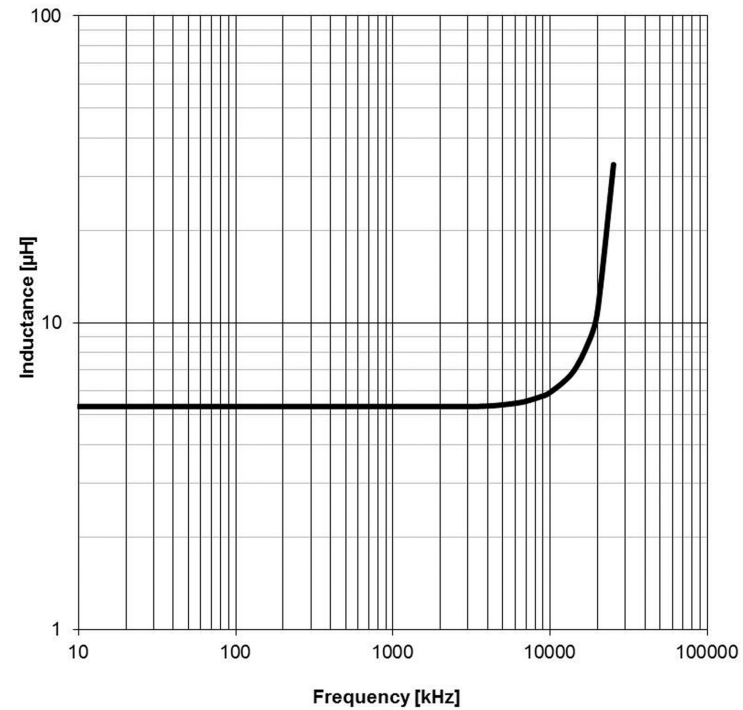

**F2 Typical Inductance vs. Frequency Characteristics:**

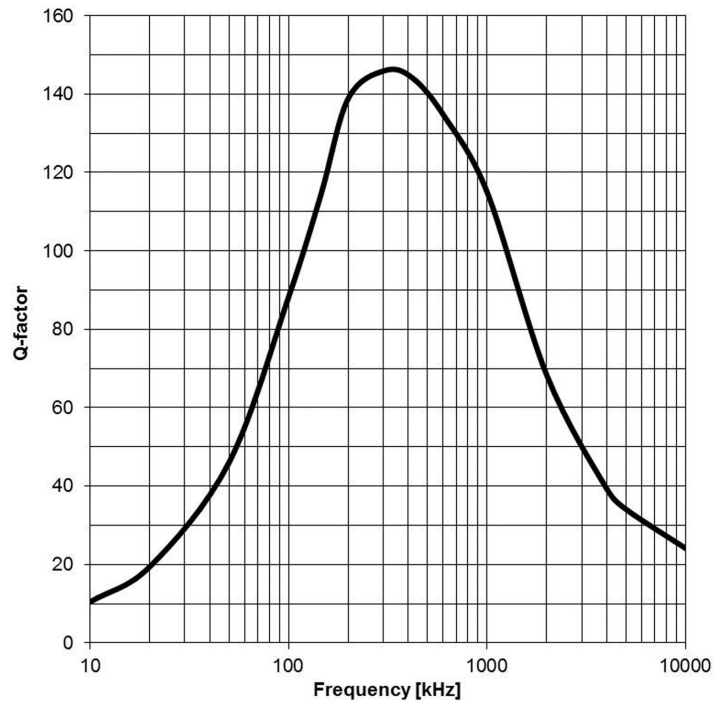

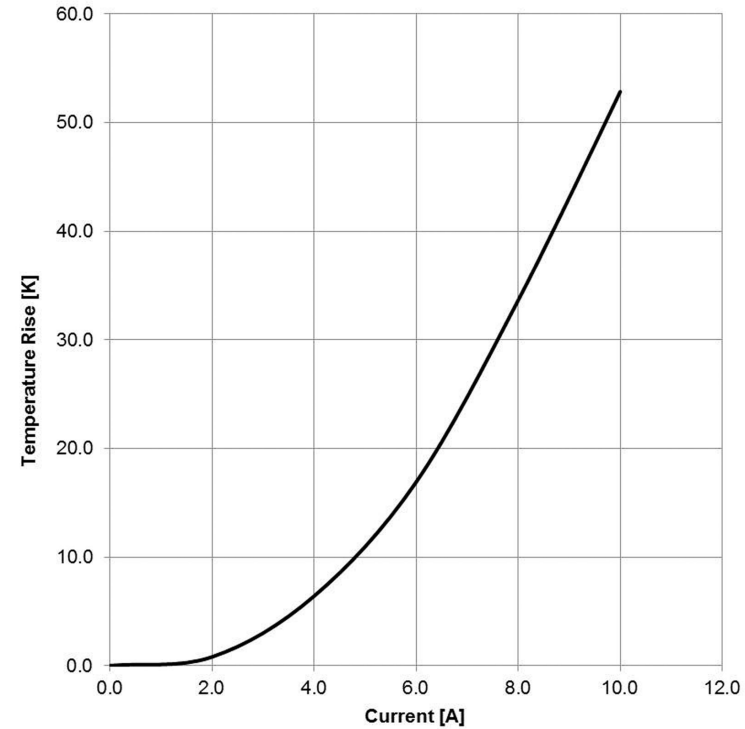

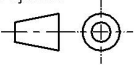
