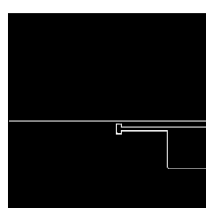

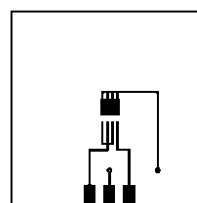

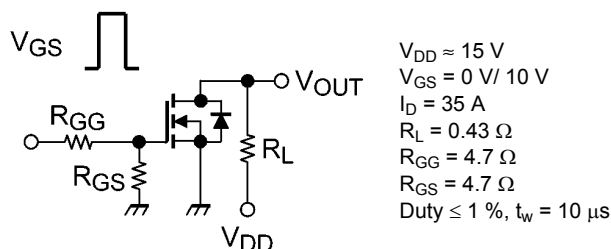


Fig. 6.2.1 Switching Time Test Circuit

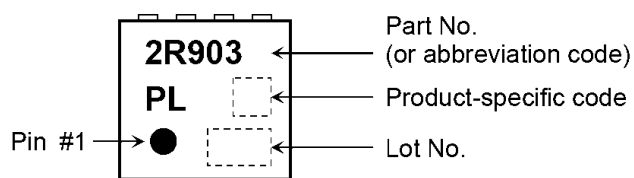

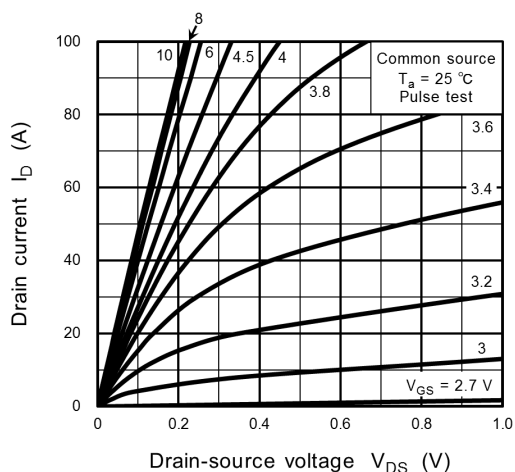

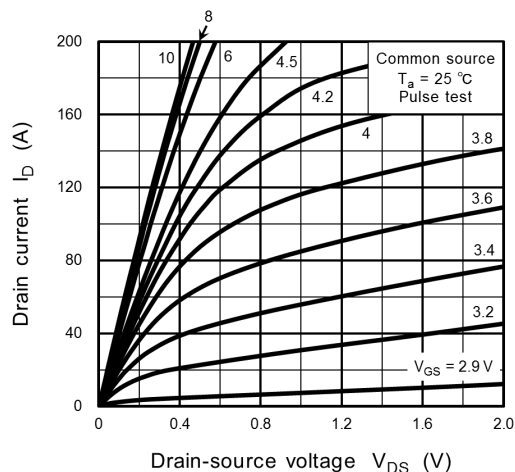

**Fig. 7.1 Marking**

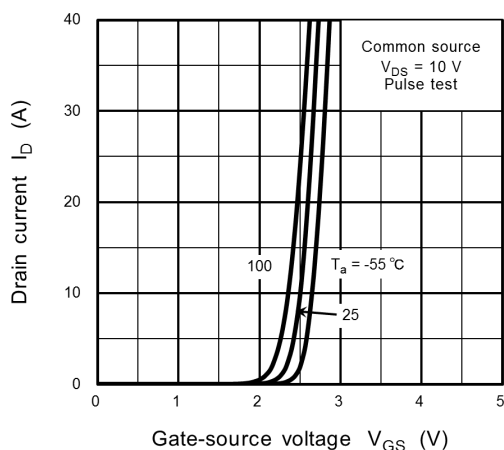

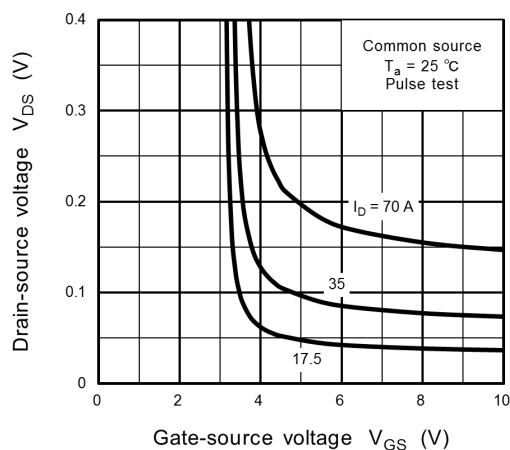
**Fig. 8.1  $I_D - V_{DS}$**



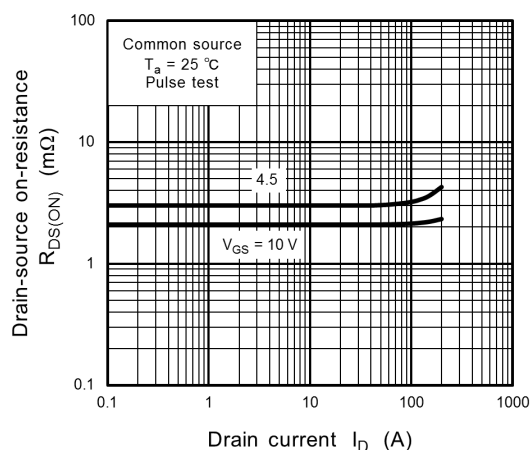
**Fig. 8.2  $I_D - V_{DS}$**



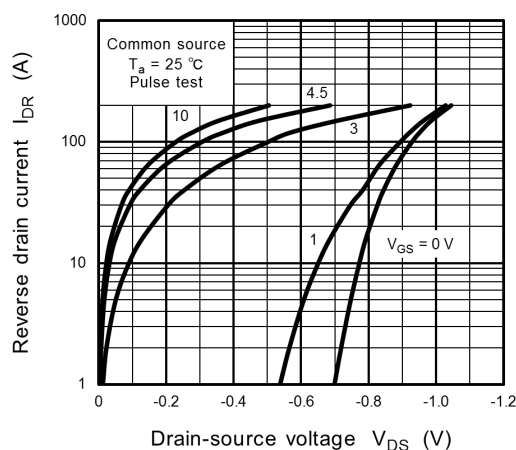
**Fig. 8.3  $I_D - V_{GS}$**



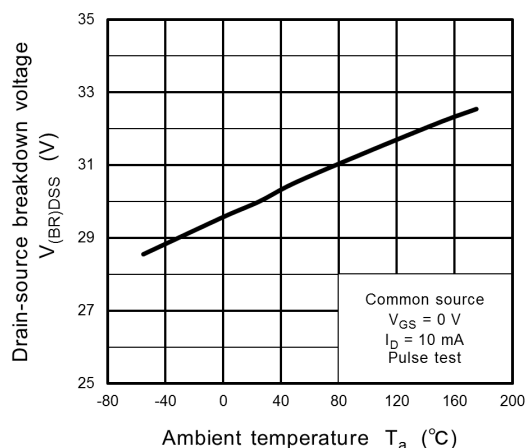
**Fig. 8.4  $V_{DS} - V_{GS}$**



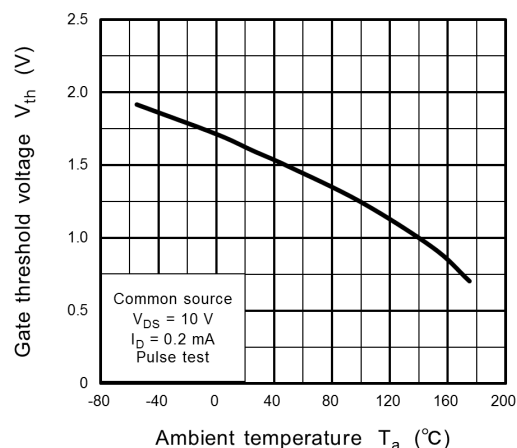
**Fig. 8.5  $R_{DS(ON)} - I_D$**



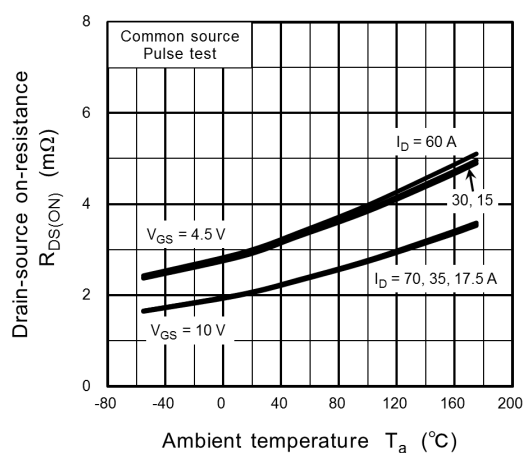
**Fig. 8.6  $I_{DR} - V_{DS}$**



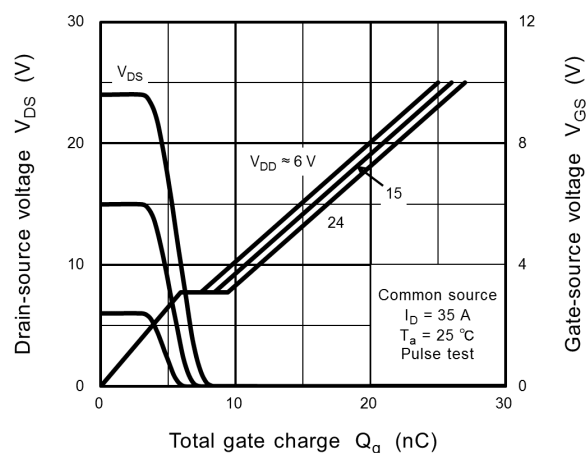
**Fig. 8.7  $V_{(BR)DSS} - T_a$**



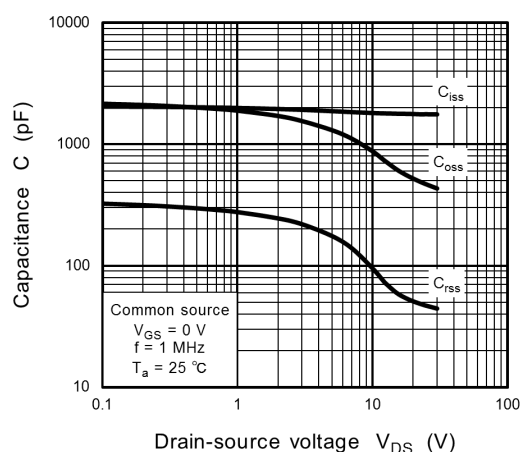
**Fig. 8.8  $V_{th} - T_a$**



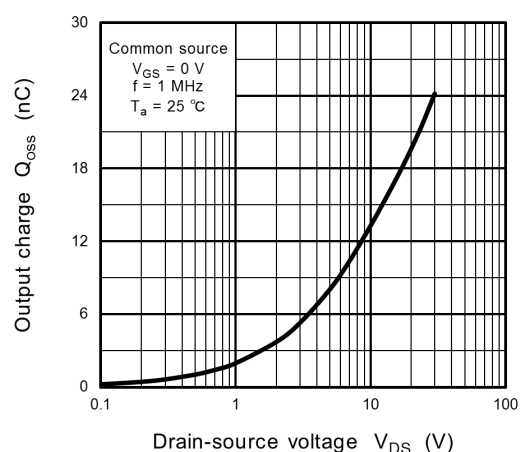
**Fig. 8.9  $R_{DS(ON)} - T_a$**



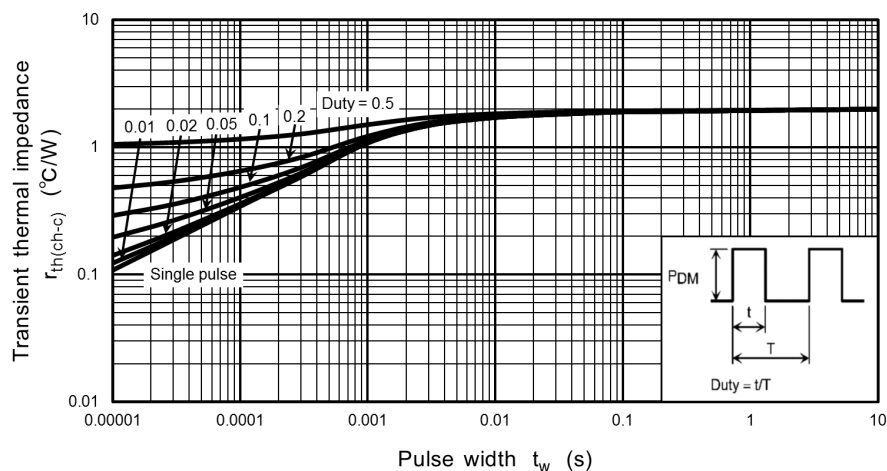
**Fig. 8.10 Dynamic Input/Output Characteristics**



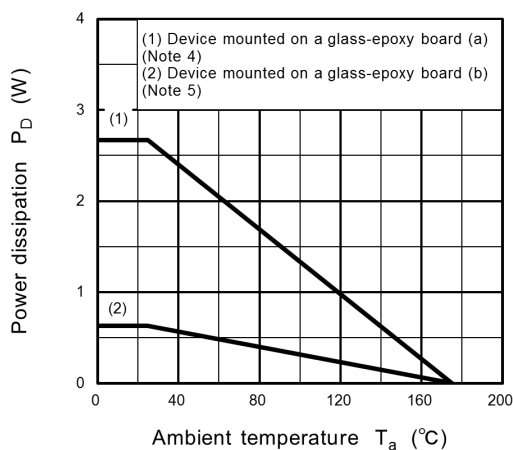
**Fig. 8.11 Capacitance -  $V_{DS}$**



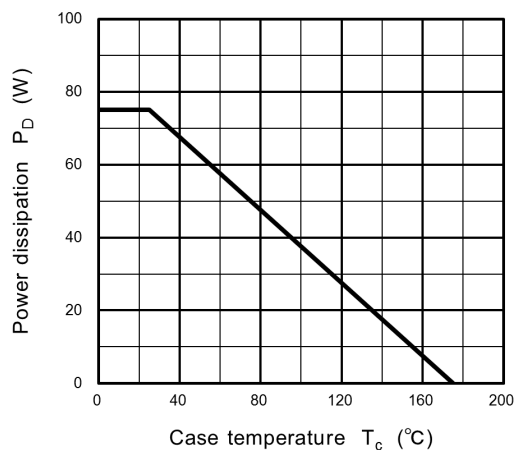
**Fig. 8.12  $Q_{oss} - V_{DS}$**



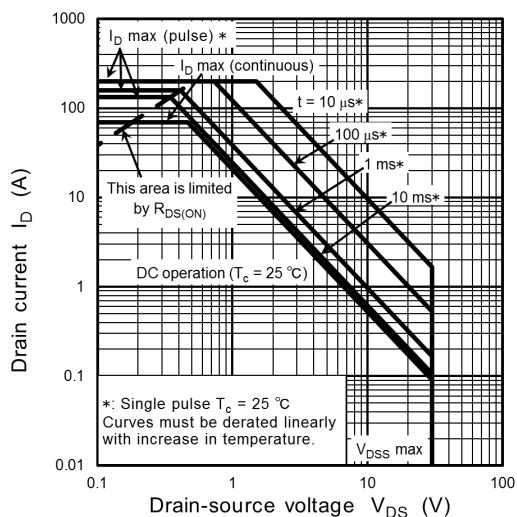
**Fig. 8.13  $r_{th} - t_w$**

(Guaranteed Maximum)

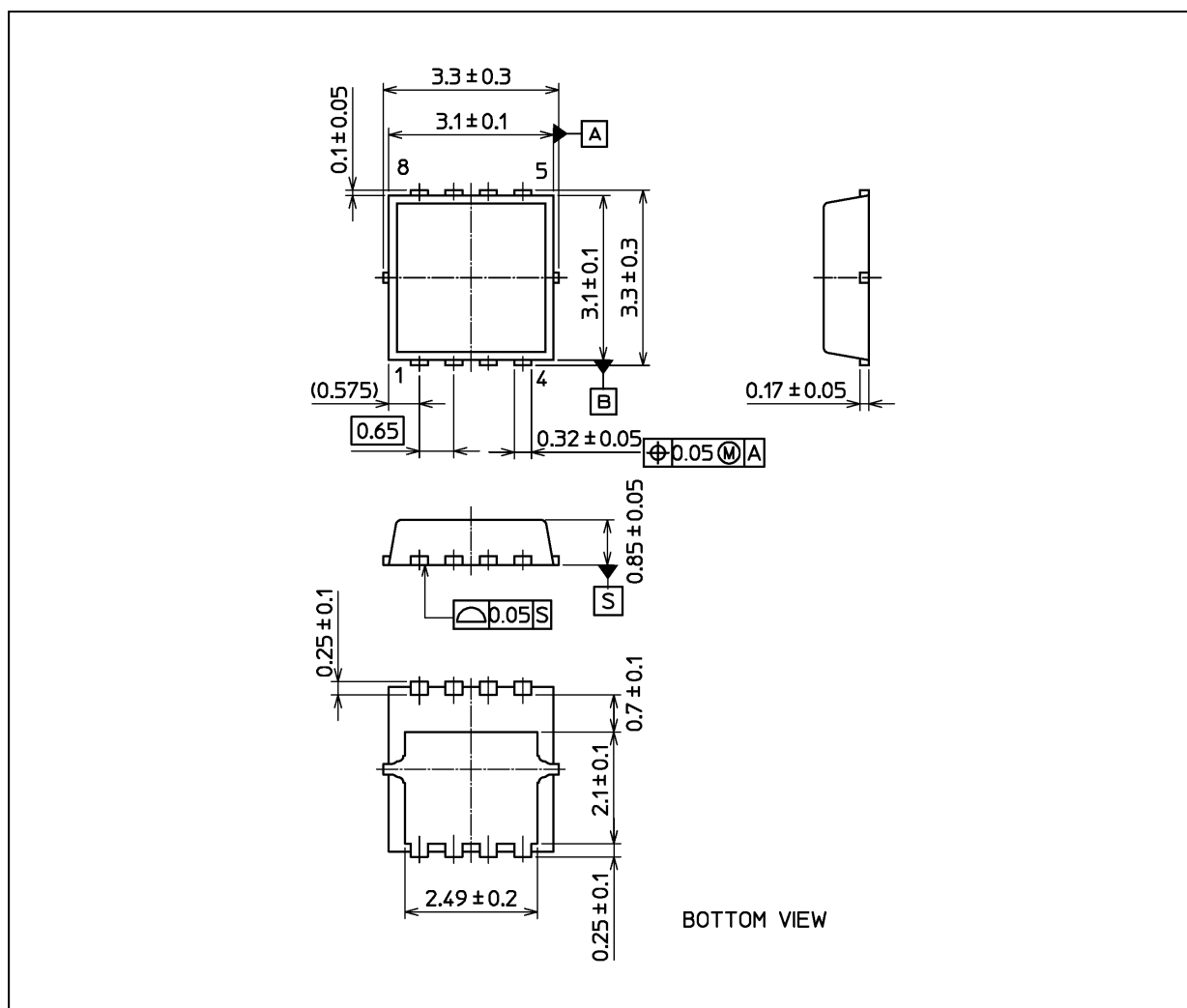


**Fig. 8.16 Safe Operating Area**
