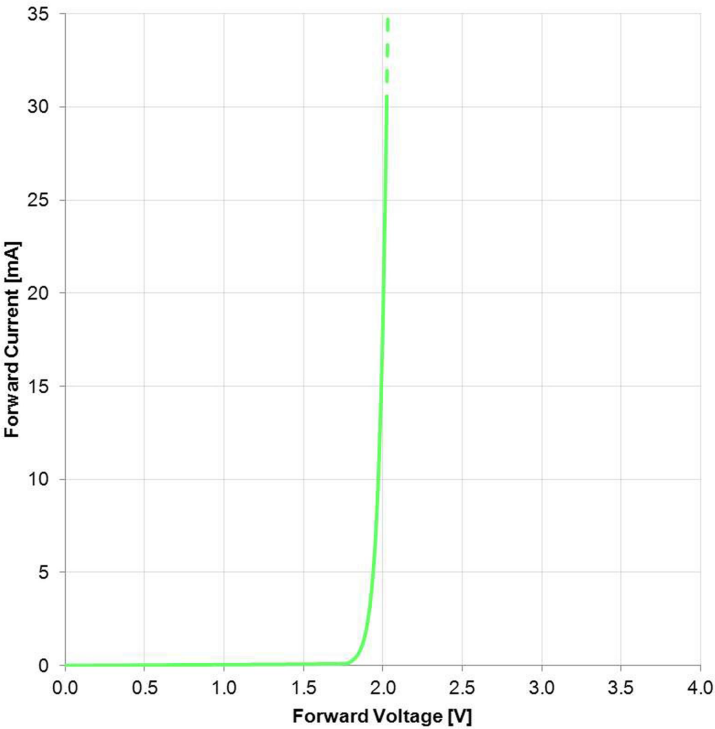






F3 Forward Current vs. Forward Voltage:

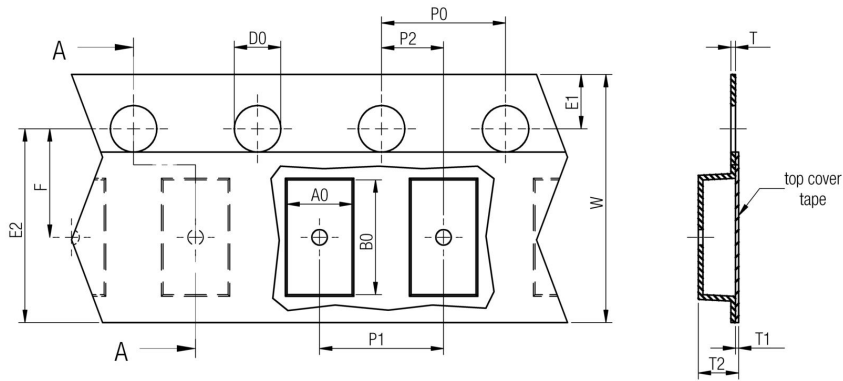
F5 Derating Curve:



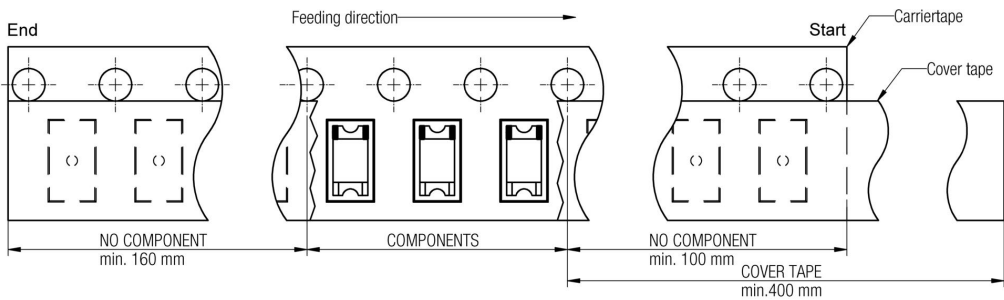
