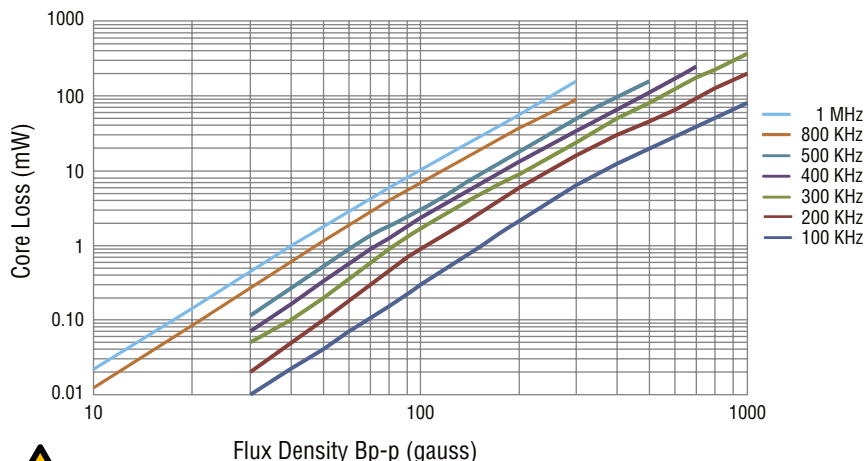

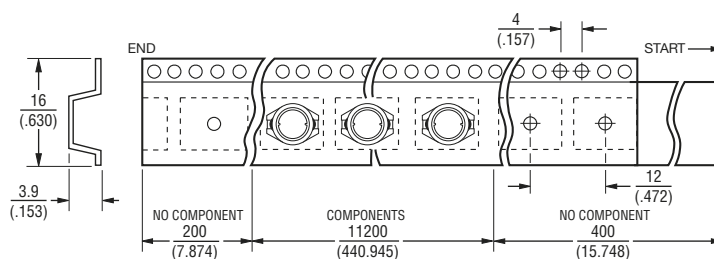
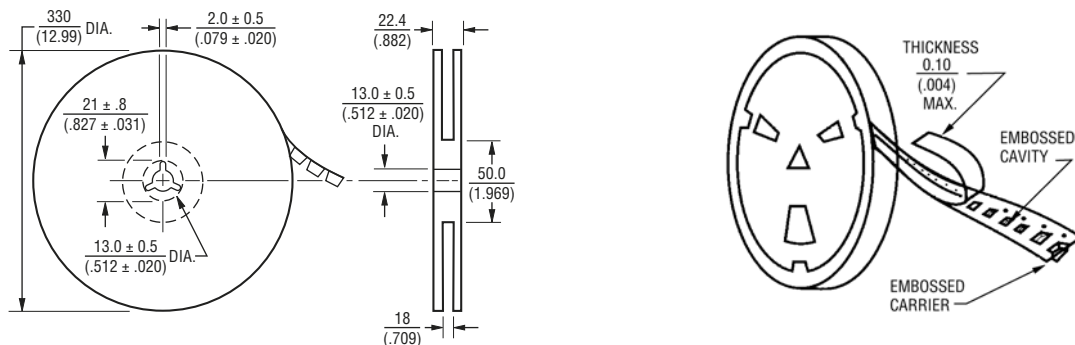
Soldering Profile
