



SN54ALS273 . . . J PACKAGE SN74ALS273 . . . DW OR N PACKAGE (TOP VIEW)







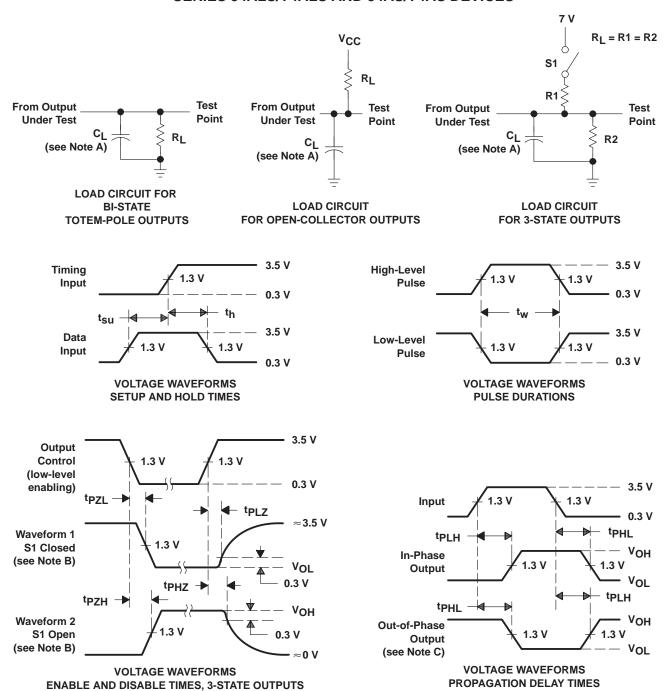
