



Fig 1. Continuous drain current as a function of mounting base temperature.




Normalized total power dissipation as a function of mounting base temperature




Fig 4. Drain-source on-state resistance as a function of drain current; typical values.




Fig 5. Normalized drain-source on-state resistance factor as a function of junction temperature

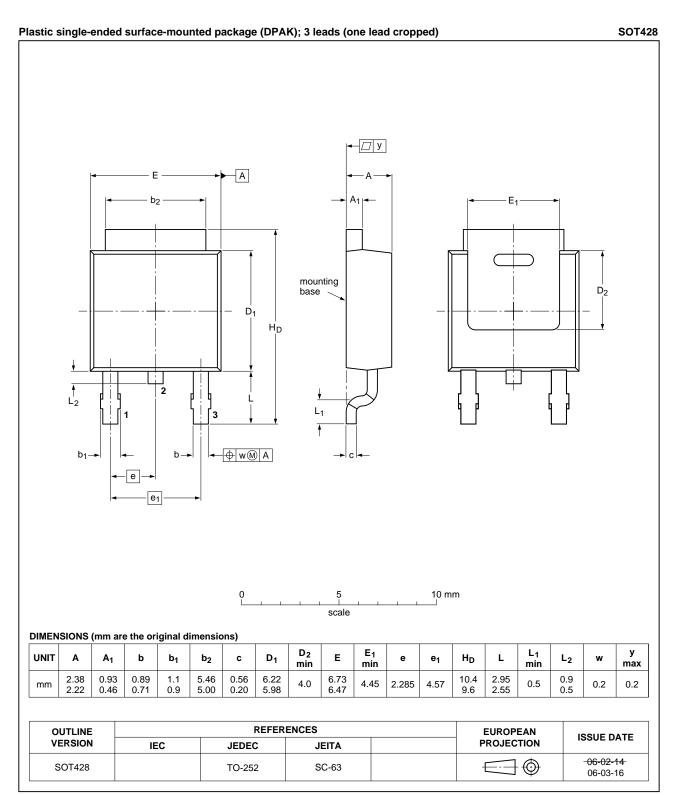


Fig 6. Package outline SOT428 (DPAK)
