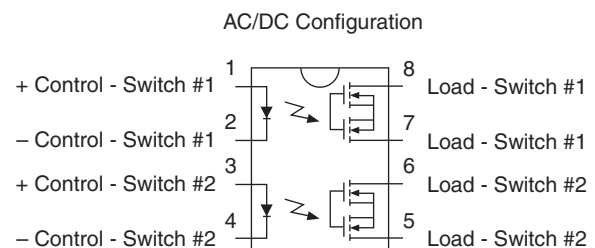

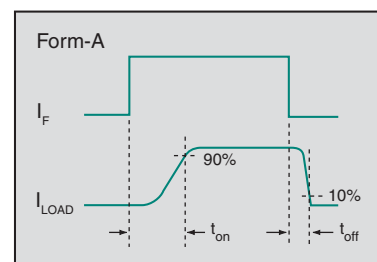

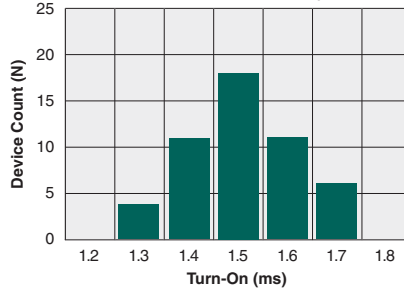

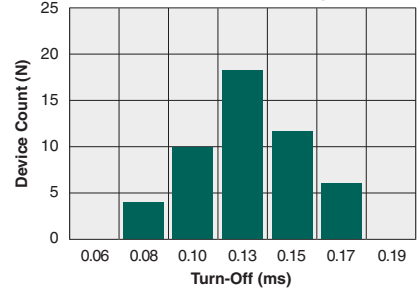
Typical LED Forward Voltage Drop

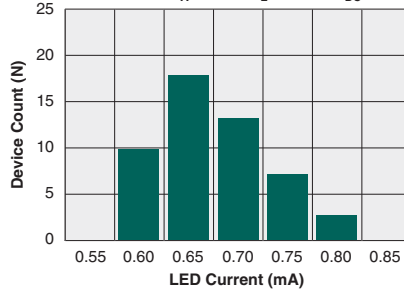
Typical Turn-Off Time

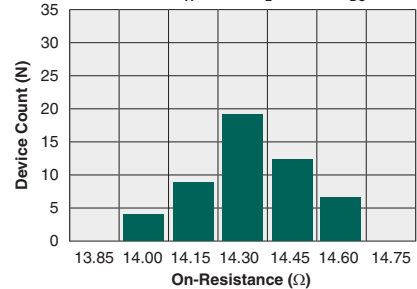
Typical  $I_F$  for Switch Operation  
(N=50,  $T_A=25^\circ\text{C}$ ,  $I_L=120\text{mA}_{\text{DC}}$ )



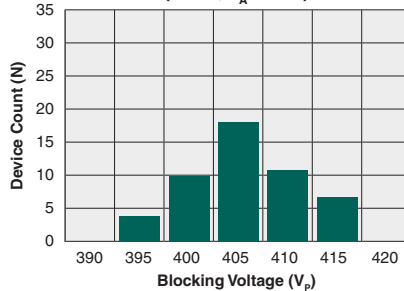
Typical  $I_F$  for Switch Dropout  
(N=50,  $T_A=25^\circ\text{C}$ ,  $I_L=120\text{mA}_{\text{DC}}$ )



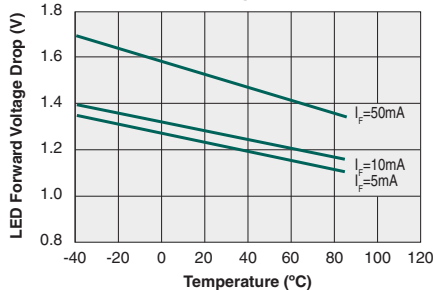
Typical On-Resistance Distribution  
(N=50,  $T_A=25^\circ\text{C}$ ,  $I_L=120\text{mA}_{\text{DC}}$ )



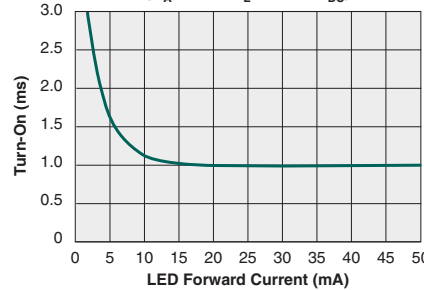
Typical Blocking Voltage Distribution  
(N=50,  $T_A=25^\circ\text{C}$ )



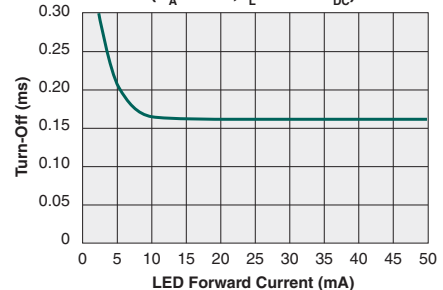
Typical LED Forward Voltage Drop vs. Temperature

( $T_A=25^\circ\text{C}$ ,  $I_L=120\text{mA}_{\text{DC}}$ )

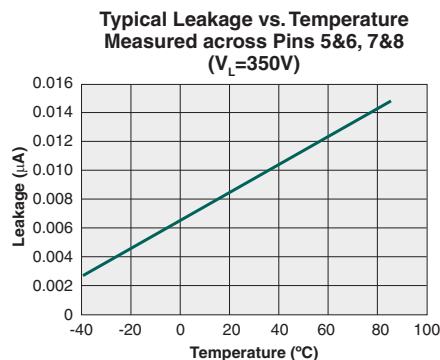


Typical Turn-Off vs. LED Forward Current

### Board Wash

IXYS Integrated Circuits Division recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since IXYS Integrated Circuits Division employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.

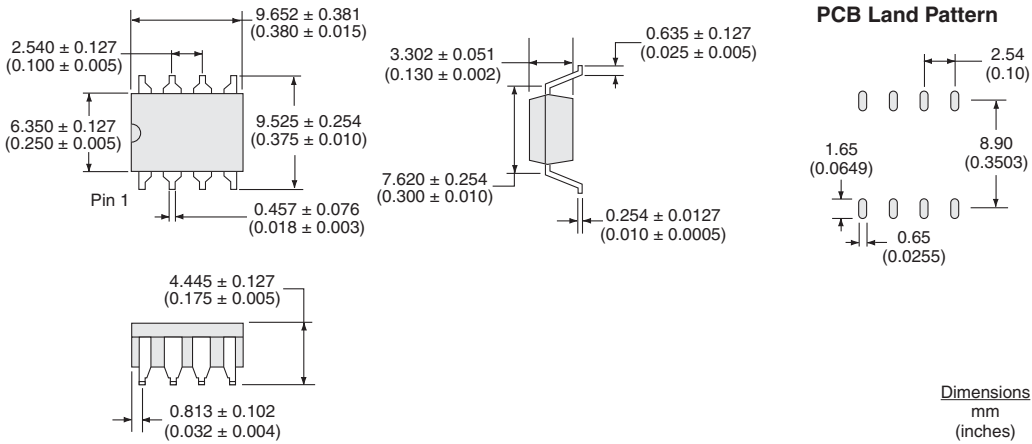

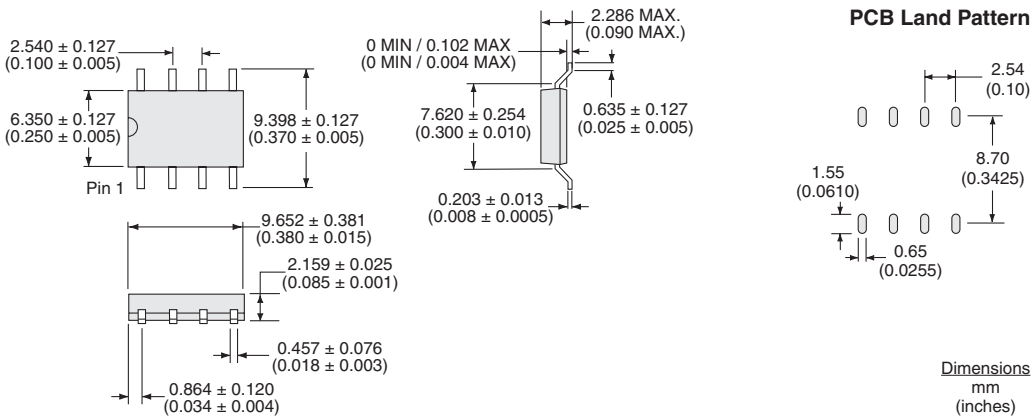
