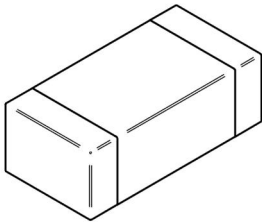

C Schematic:

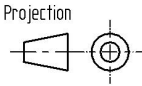

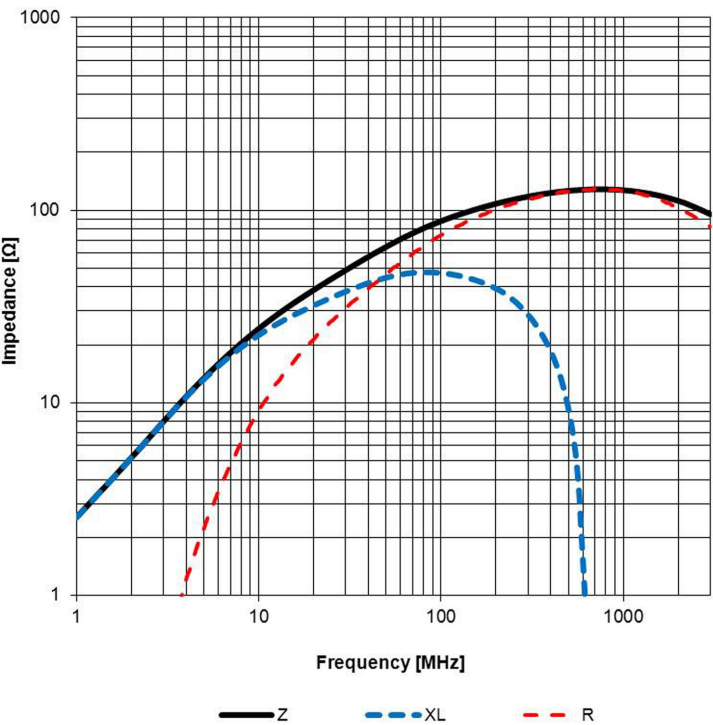
