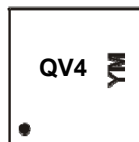
Device Schematic

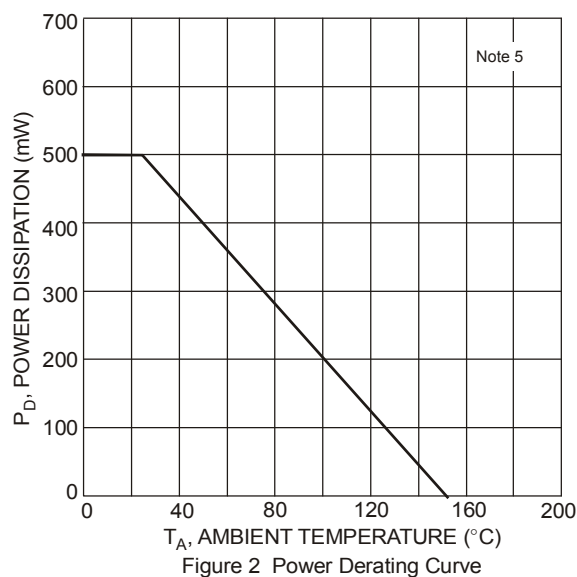
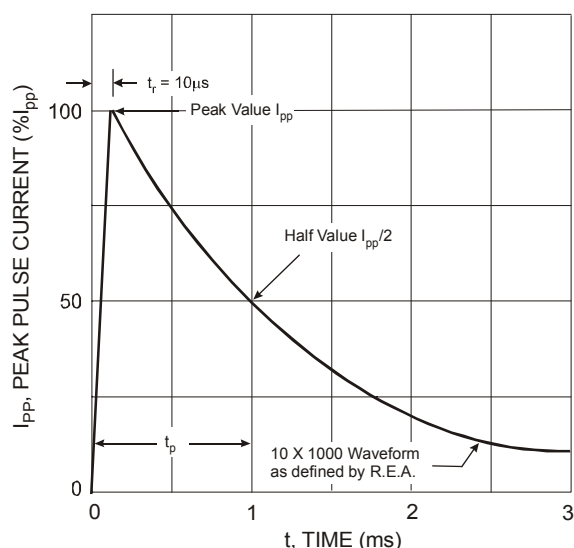

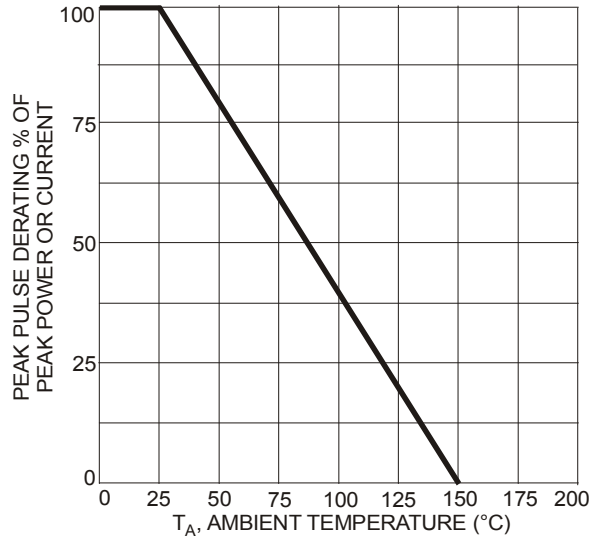


Figure 3 Power Dissipation vs. Ambient Temperature

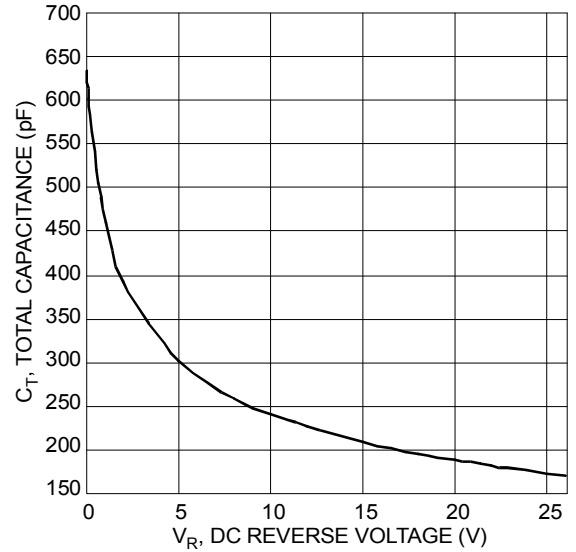


Figure 4 Typical Total Capacitance

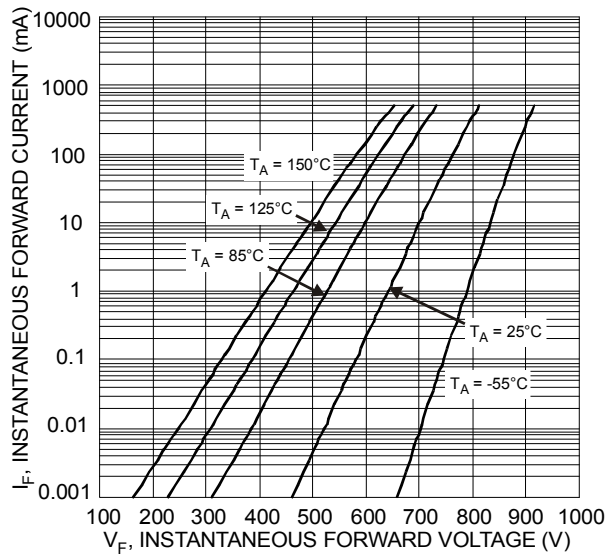


Figure 5 Typical Forward Characteristics

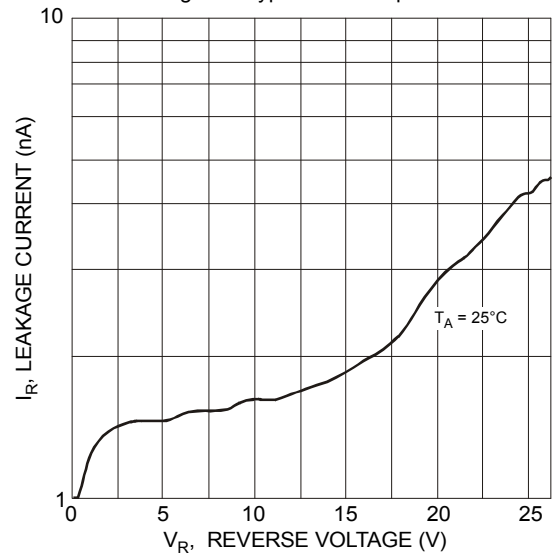
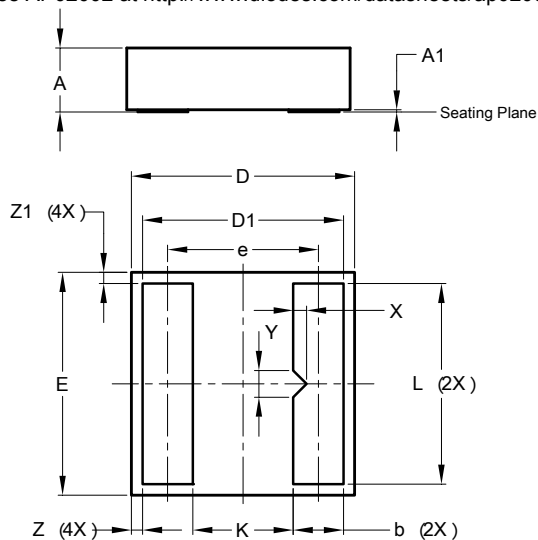


Figure 6 Typical Reverse Characteristics

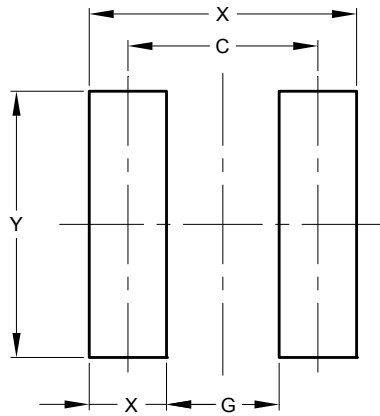
