

### **Typical Inductance vs. Current Characteristics:**




# **Typical Inductance vs. Frequency Characteristics:**







# **Q-Factor vs. Frequency:**




# **Typical Temperature Rise vs. Current Characteristics:**


Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.


