# Low-power dual Schmitt trigger Rev. 1 — 12 November 2015

#### **General description** 1.

The 74AXP2G17 is a dual Schmitt trigger buffer. It can transform slowly changing input signals into sharply defined, jitter-free output signals.

This device ensures very low static and dynamic power consumption across the entire V<sub>CC</sub> range from 0.7 V to 2.75 V. It is fully specified for partial power down applications using I<sub>OFF</sub>. The I<sub>OFF</sub> circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.









Fig 9. Additional tpd versus load capacitance





Fig 10. Additional tpd versus load capacitance





Fig 11. Additional tpd versus load capacitance





Fig 12. Additional t<sub>pd</sub> versus load capacitance








Fig 15. Package outline SOT886 (XSON6)




Fig 16. Package outline SOT1115 (XSON6)




Fig 17. Package outline SOT1202 (XSON6)
