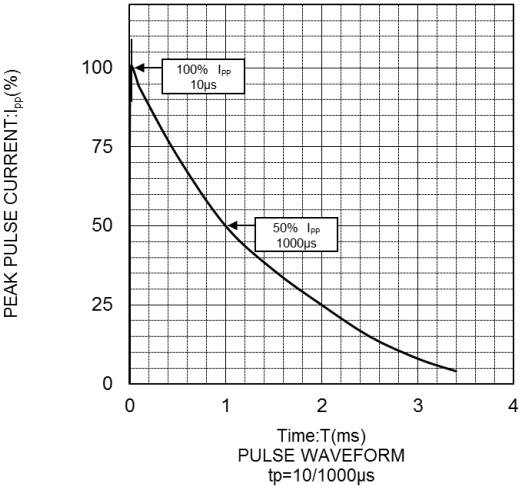
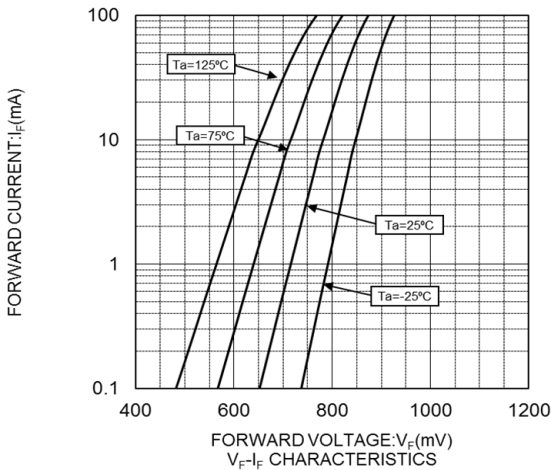
● Electrical Characteristic Curves



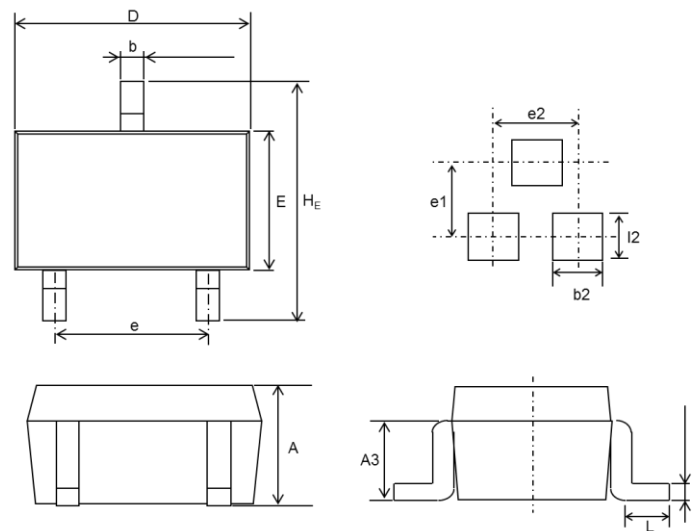

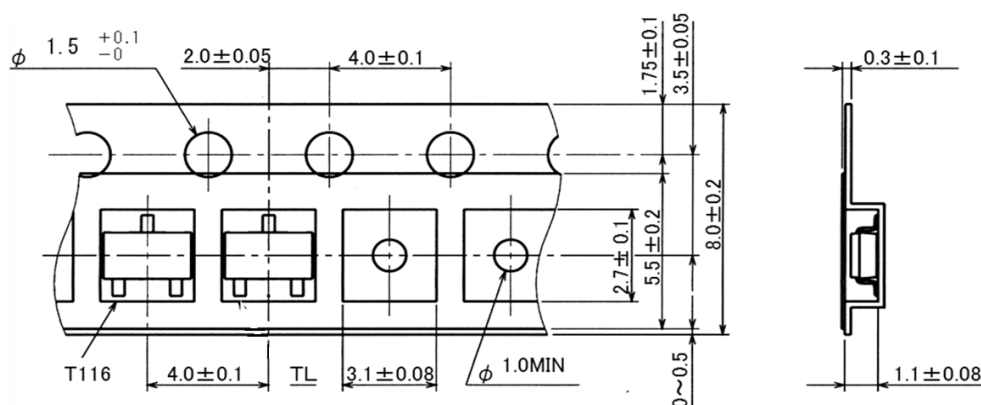
