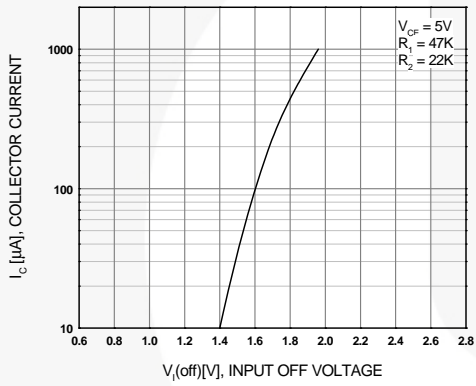

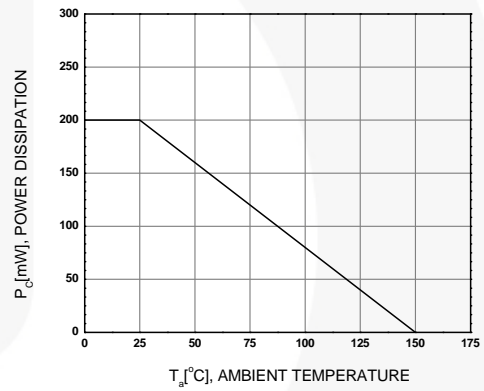
**Figure 1. DC Current Gain**



**Figure 2. Input-On Voltage**



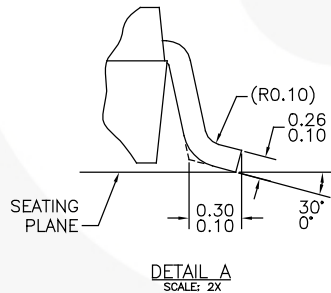
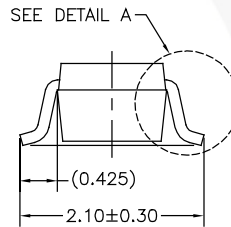
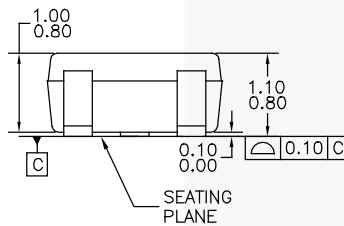
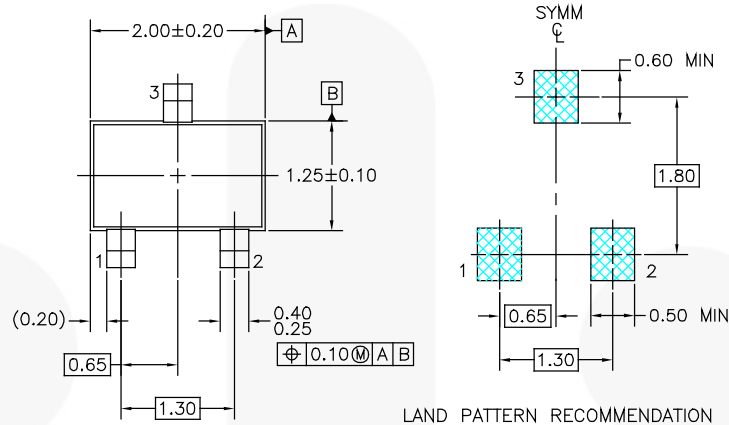
**Figure 3. Input-Off Voltage**
