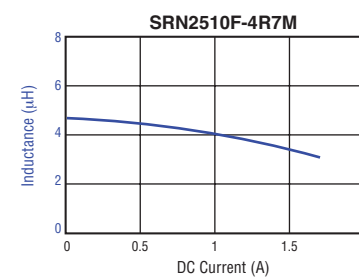
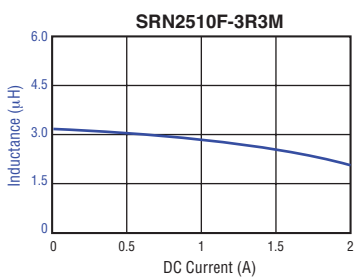
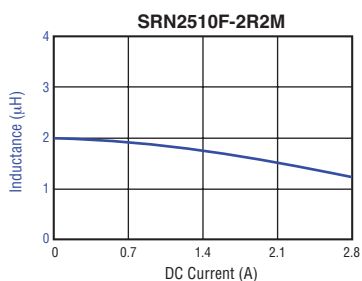
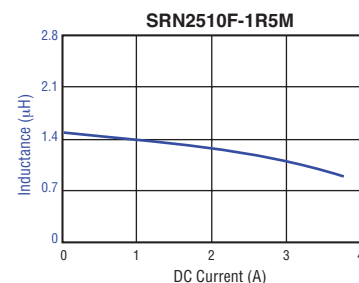
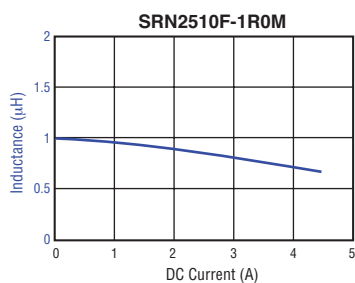
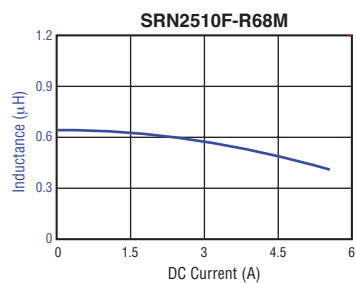
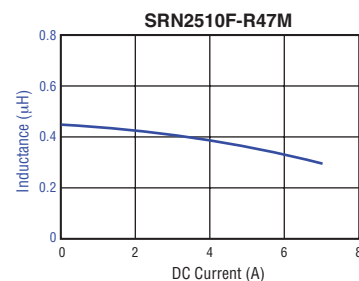
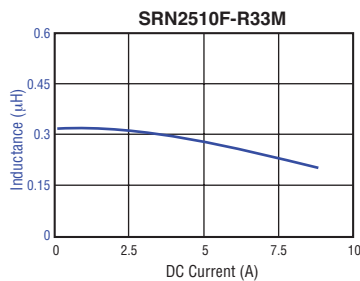
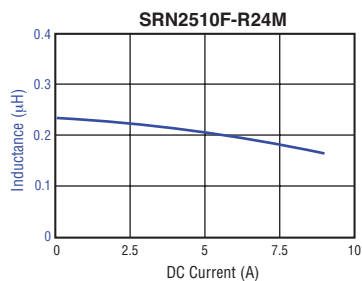


## Soldering Profile

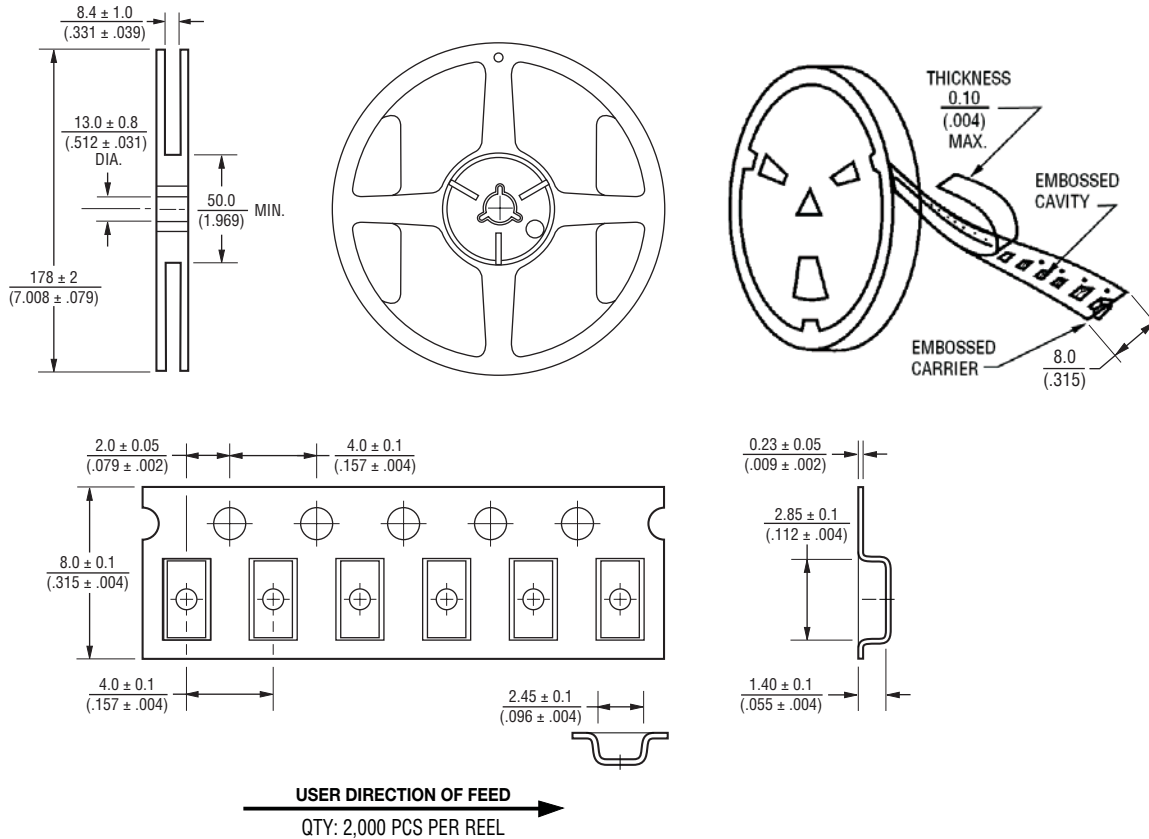
