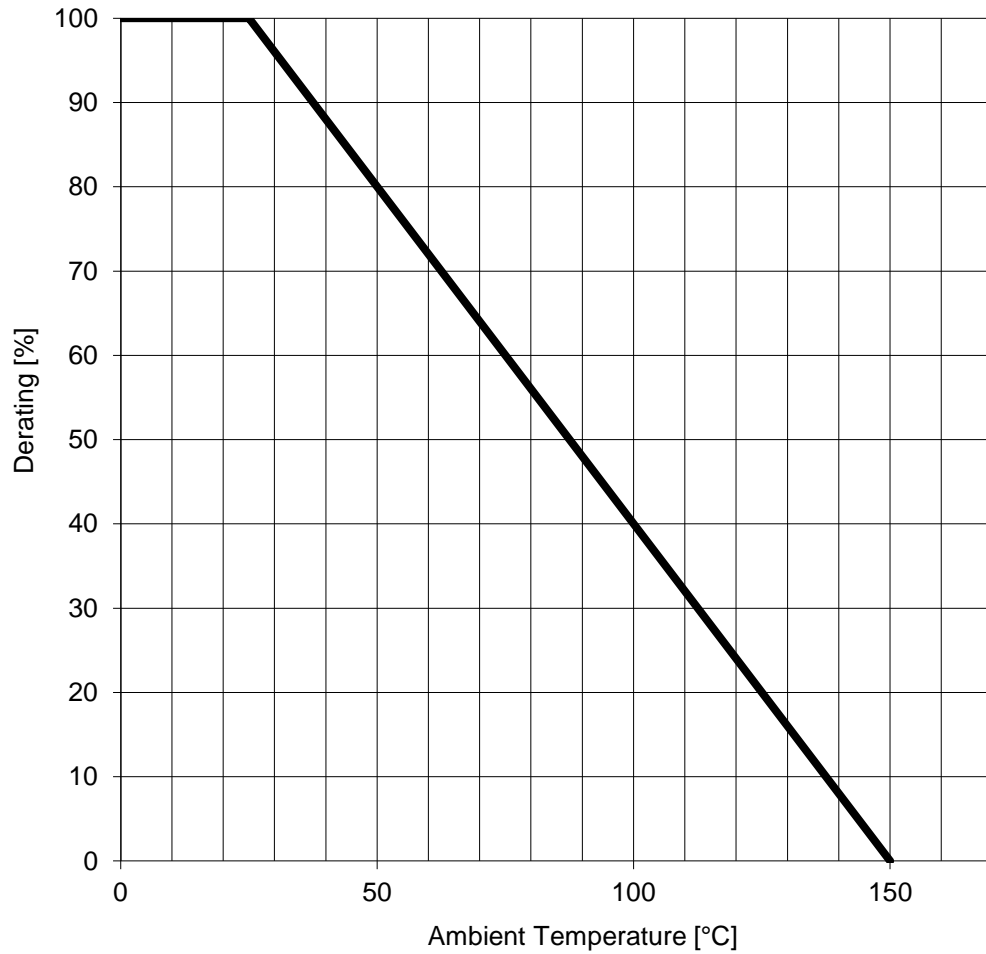

## Steady State Power Dissipation Derating






