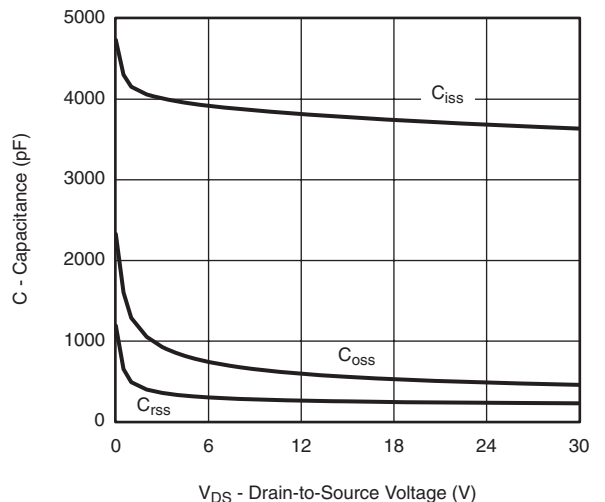

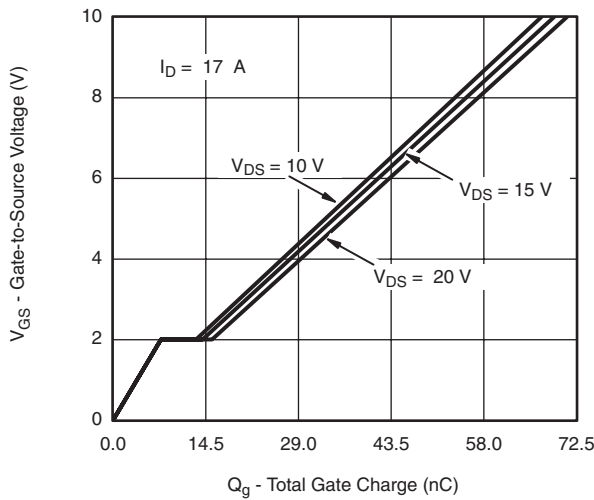

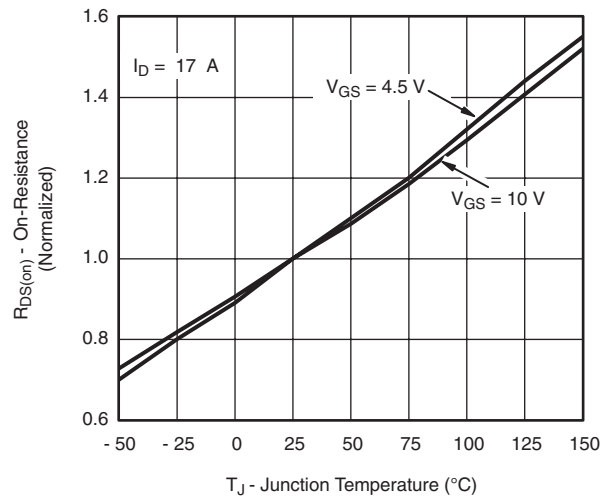
On-Resistance vs. Drain Current and Gate Voltage

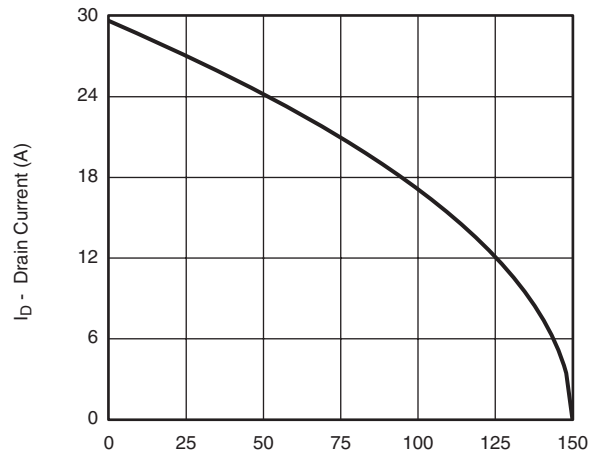


On-Resistance vs. Junction Temperature

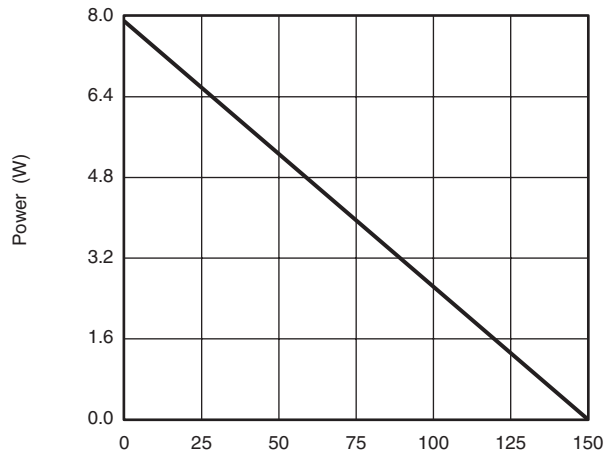

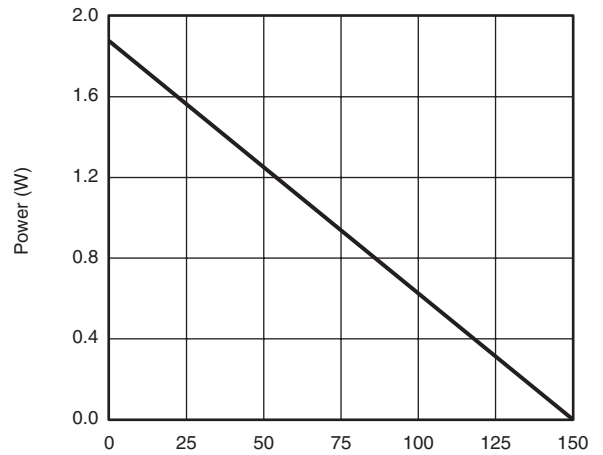

Current Derating*



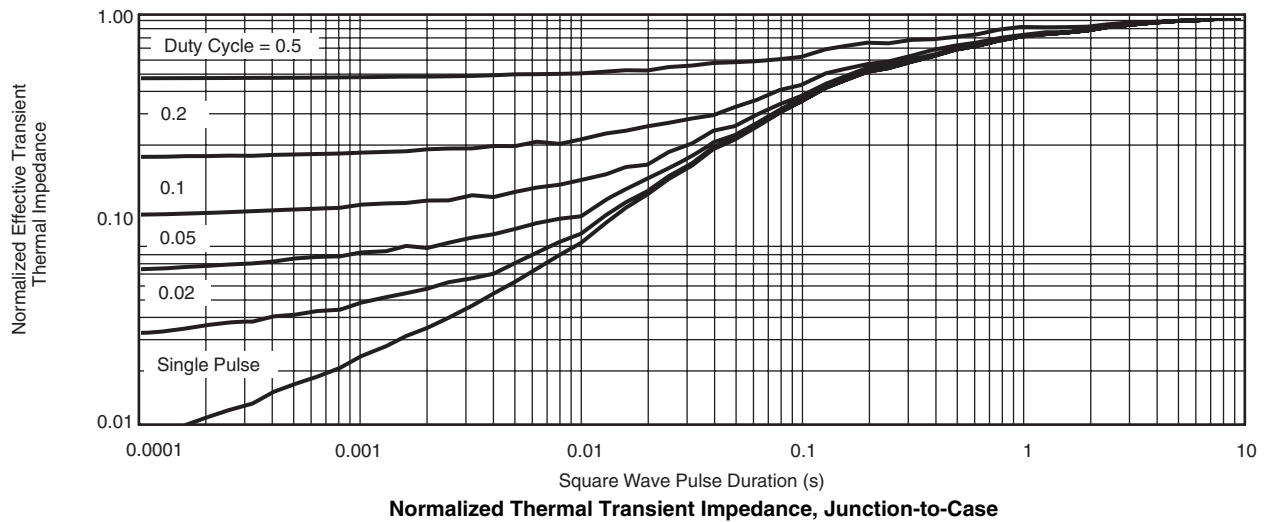
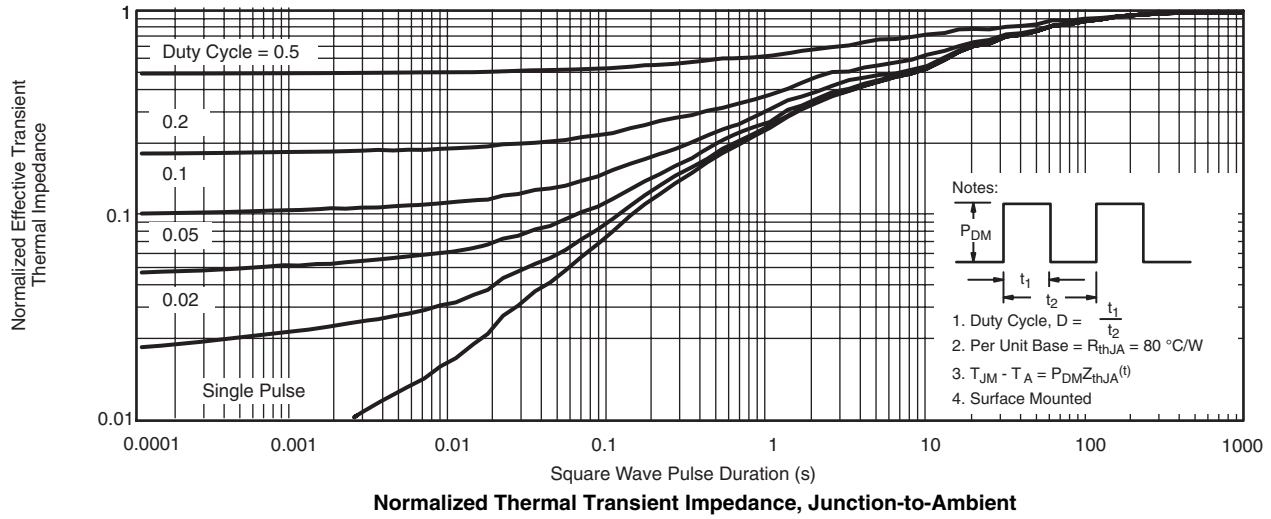
T_C - Case Temperature (°C)
