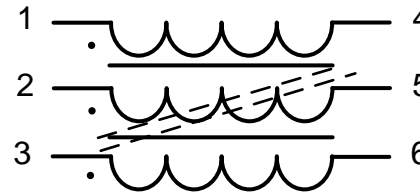

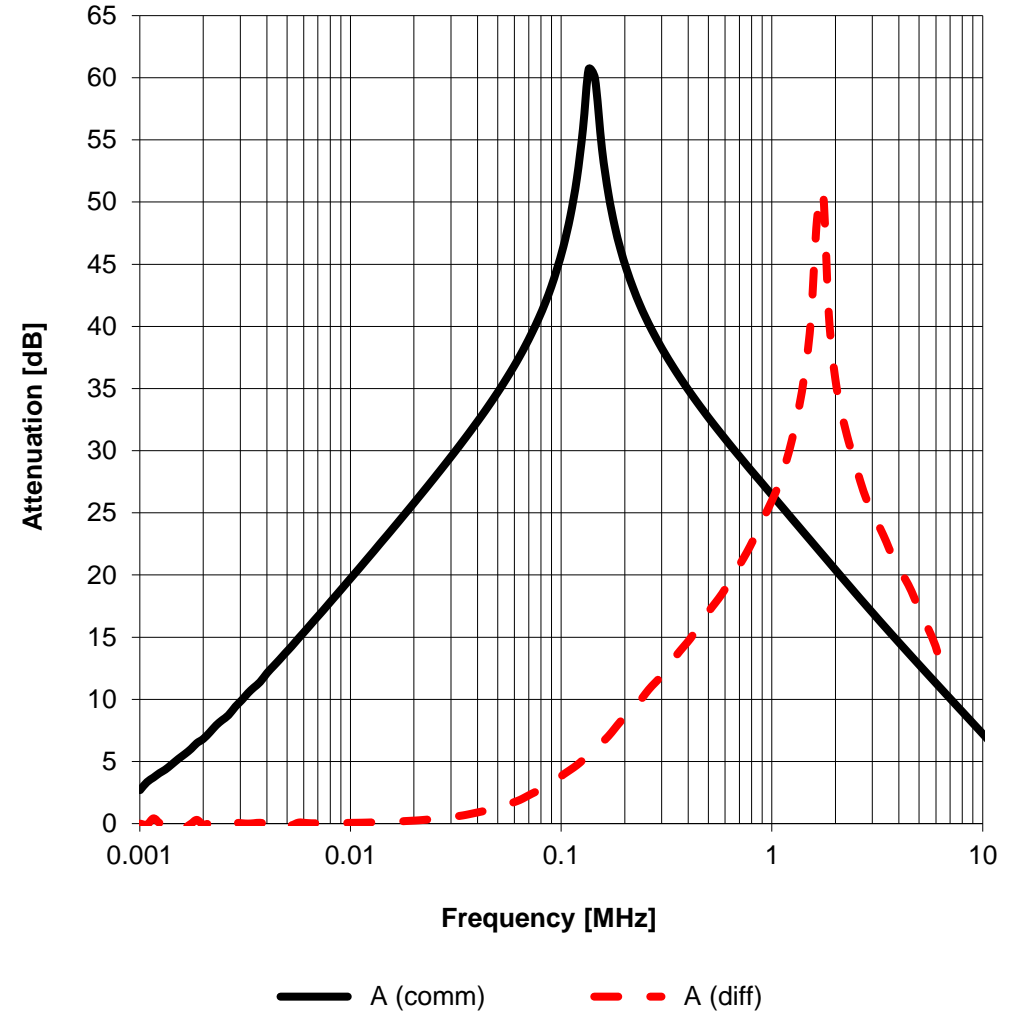
Common Mode

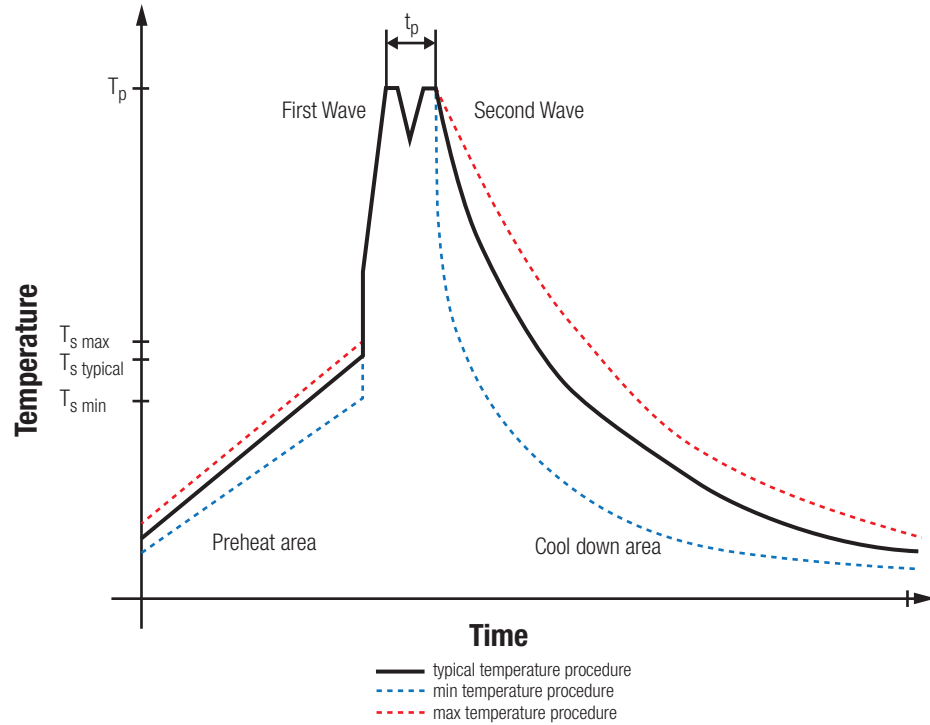


