C Schematic:



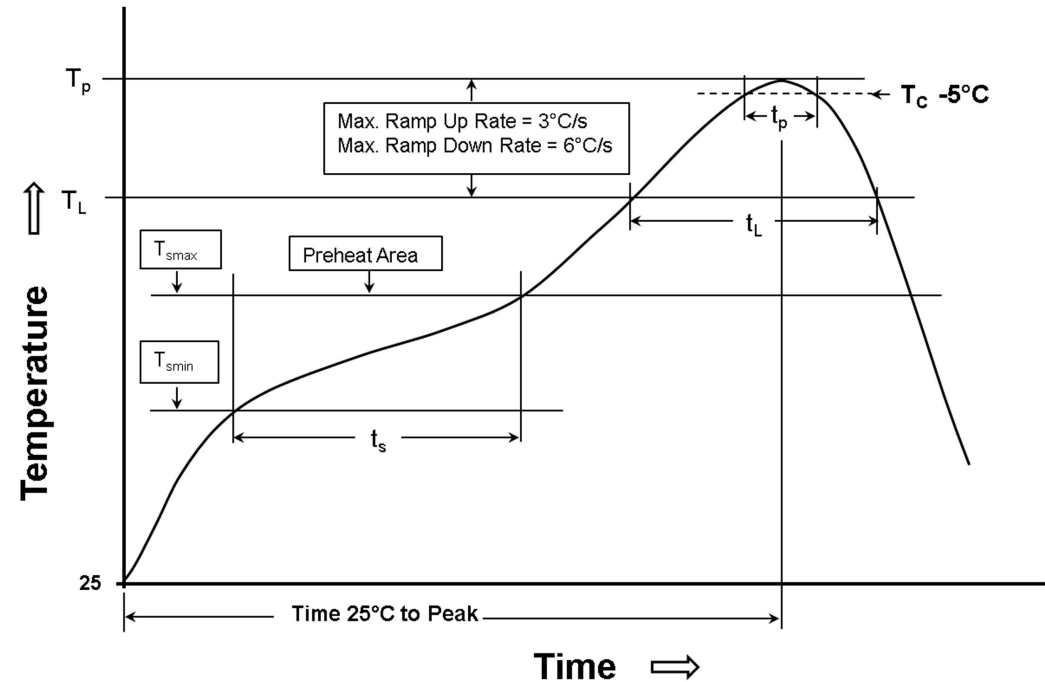


